Brief Details.

On 22/04/2019 at about 1930hrs, I was travelling in my motorcycle bearing registration plate FX2401R towards the direction of Changi Airport. I was riding along the right most lane and maneuvering my motorcycle to the left. As I was at the dotted white line dividing the 3rd and 4th lane, suddenly a red car bearing registration plate SLW6241T which was on the 3rd lane signal left before immediately switching lane to the 4rd lane. I quickly swerve my motorcycle to the left to maneuver out of the way and I ended up on the 4th lane. However I lost control and was unable to brake in time before colliding into the vehicle in front of me, a car bearing SLE4132H.

I fell off my motorcycle and landed on my right side. As I was about to stand up, I noticed that the red vehicle SLW6241 was about to resume travelling along the road on the 3rd lane however I reach out a hand and gesture for it to stop. I felt abrasion on right elbow, both legs and on my buttocks and I was given 4 days of medical leaves for my injuries. I also manage to communicate with the driver of SLE4132H and discovered that he had an incar camera which captured me swerving to avoid hitting SLW6241 when it switches lane abruptly after signaling for what I felt was less than a second. I would like to mentioned that I do not have a in-camera installed on my motorcycle or helmet.


