As you see in the sketch plan and photo he should stop his vehicle at my neighbour's house highlighted in pink to avoid the accident. I regretted I did not take a photo of his licence plate but got his driving licence and hp. I also took photo that his car was slightly dented as indicated in my photo. However I noticed there were many old scratches which was not from the hit. The taxi driver also checked his bonnet and everything else was in place and order. As my car has minor scratches I will not claim.

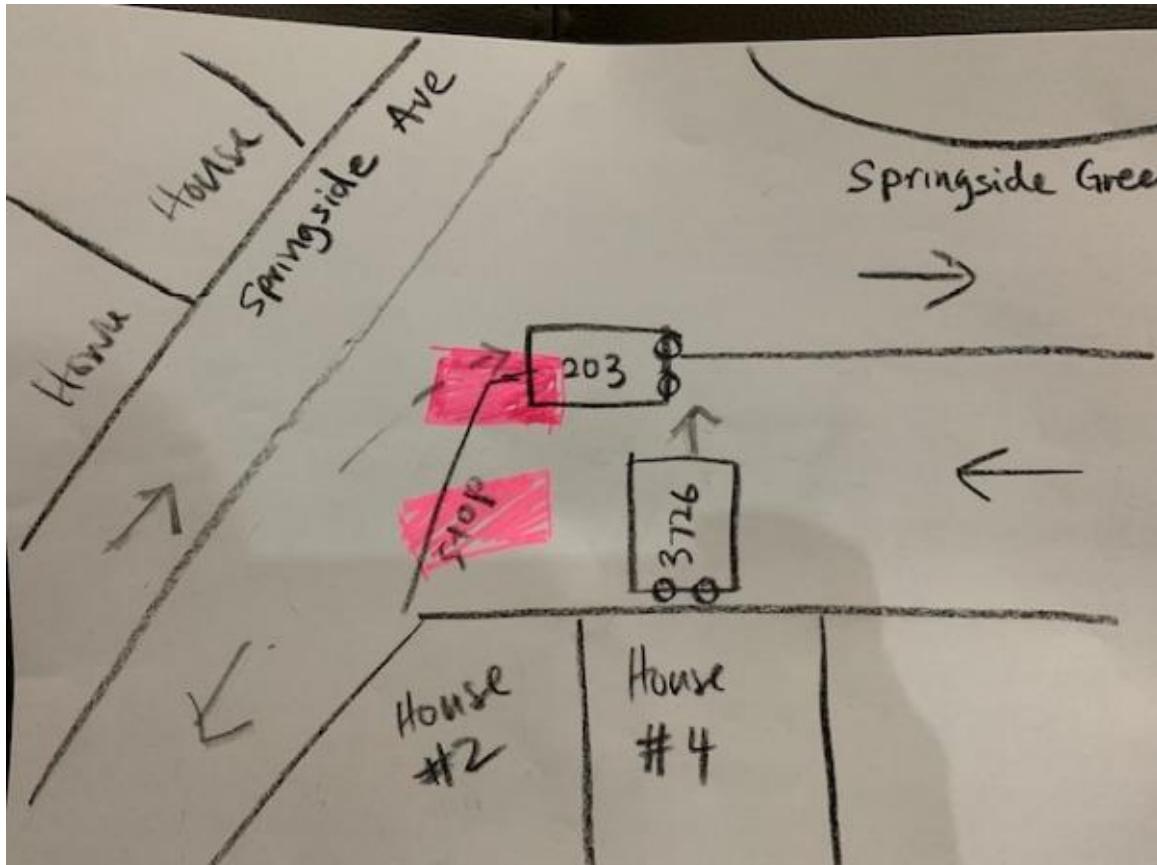

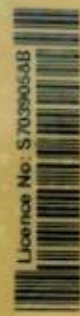

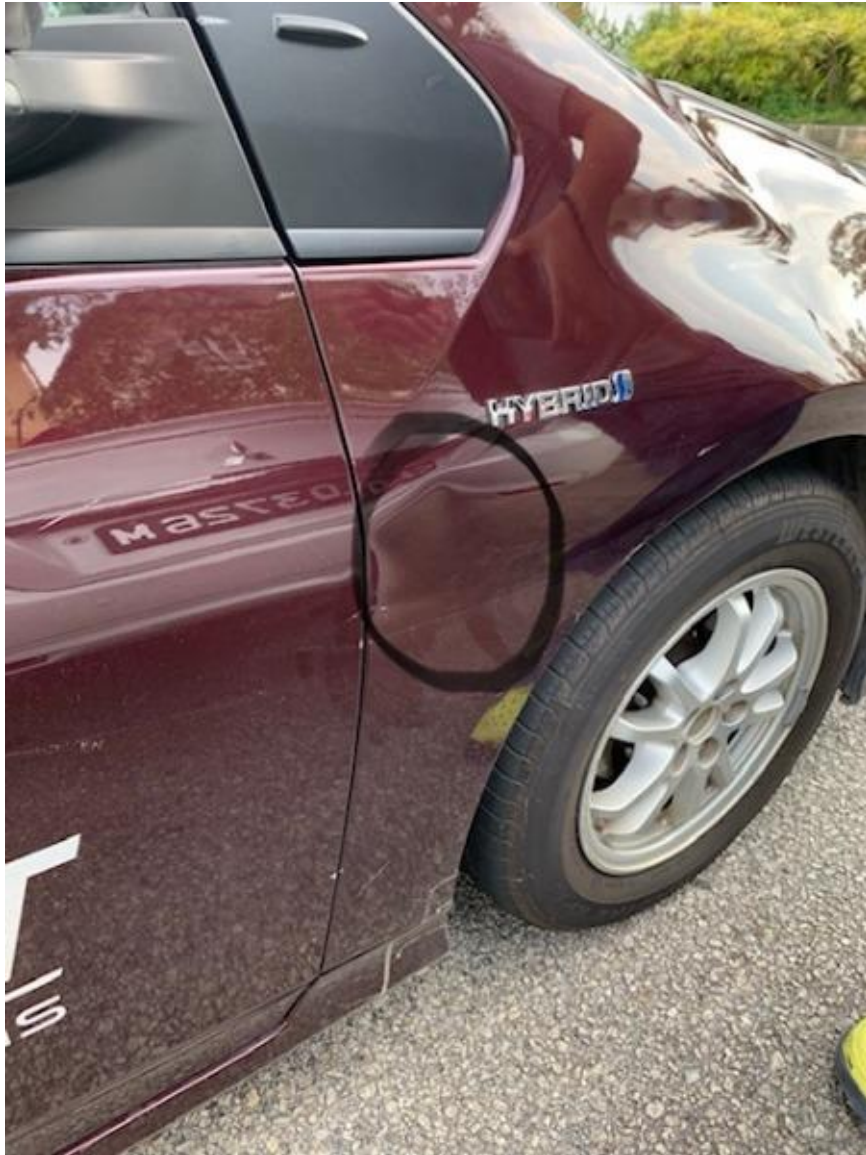
