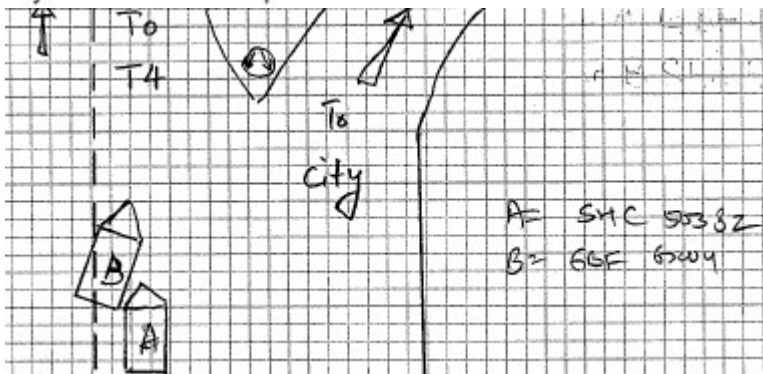
Enclosed is video footage for your reconsideration.
