Insurance Garm for dispute between SKQ 3829 L and SLN 7262Z

It was 10 Apr 2019, Saturday, evening when I was novigating along Orchard Turn, at the vicinity of Ngee Ann City.

The traffic along the road has always been busy and I (SKQ 3829 L) had been diving at a slow speed (20-40 kmh) on the main road.

At around 5.42pm, a dark purple hatdback Honda Vezel, SLN 7262Z, had swarved in from my left peripheral vision from an adjoining road whose merges into the main road.

Although I had braked immediately when I saw him, he had not signedled and had swerved to the centre lane which I was on, instead of keeping to the utmost left lane. Both cars were not at a fast speed but I had impacted his right rear reflective light.

Both parties dighted and examined the situation. His our was dented in from his news e light to the rear, while my our hand a sight scratch on the left bonnet. I am still buffled by how the seamingly minor impact had resulted in his severe damages. Nonetholess, he had requested to proceed with insurance daims.
