



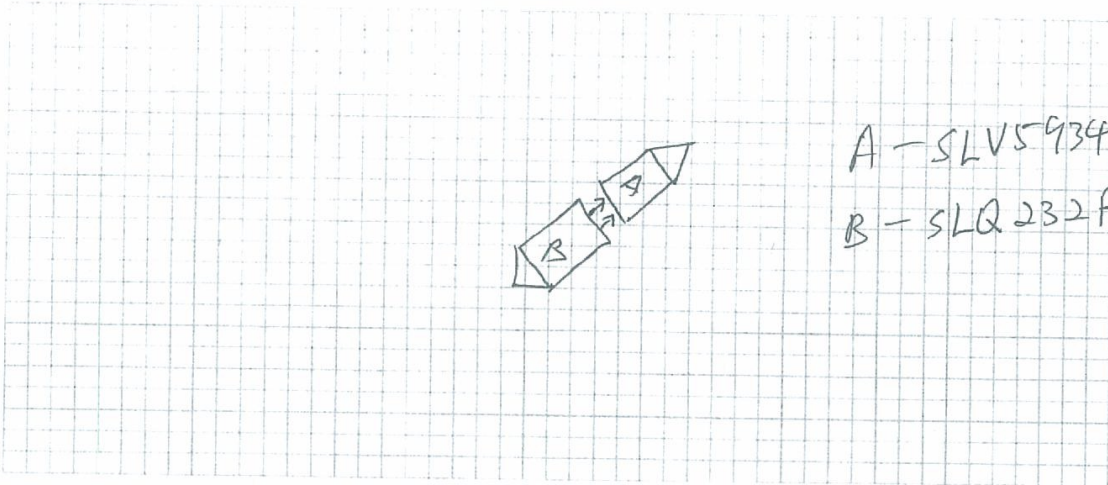

SKETCH PLAN





