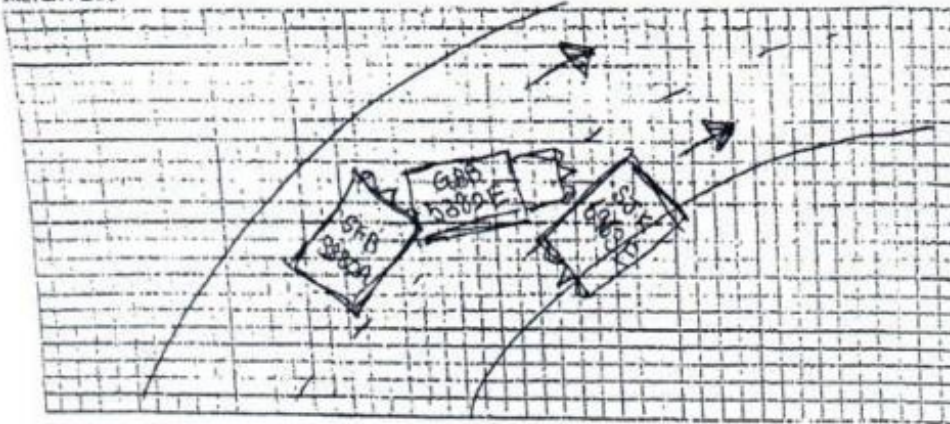

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was travelling in the left lane, and the lorry (GBB 5382 E) was on my right lane, one vehicle's spare to the front.

As we negotiated the right bend, the rear of the lorry swerved suddenly into me and hit the front bonnet and the fender on the driver's side.

Upon getting off ~~my~~ my vehicle, I realised that there was another vehicle (SJK 6963 E) facing the opposite direction of the oncoming traffic. This view was obstructed by the height of the lorry.

I have photo evidence to prove that I wasn't under any attempt to overtake the vehicle in front of me.

There's some lower back pain that was caused by the impact.

Brief Details.

I was in the left lane and the lorry (GBB 5382E) was in the right lane at a vehicle's length away.

As we were negotiating a right curve, the lorry braked suddenly and cut into my lane. I braked but the fender on the driver's side was damaged.

Only after alighting from my vehicle did I realise that the lorry was trying to avoid the other vehicle involved (SJK 6963E) which had stalled on the right side of the road and was facing oncoming traffic.

There was subsequent pain in my lower back.

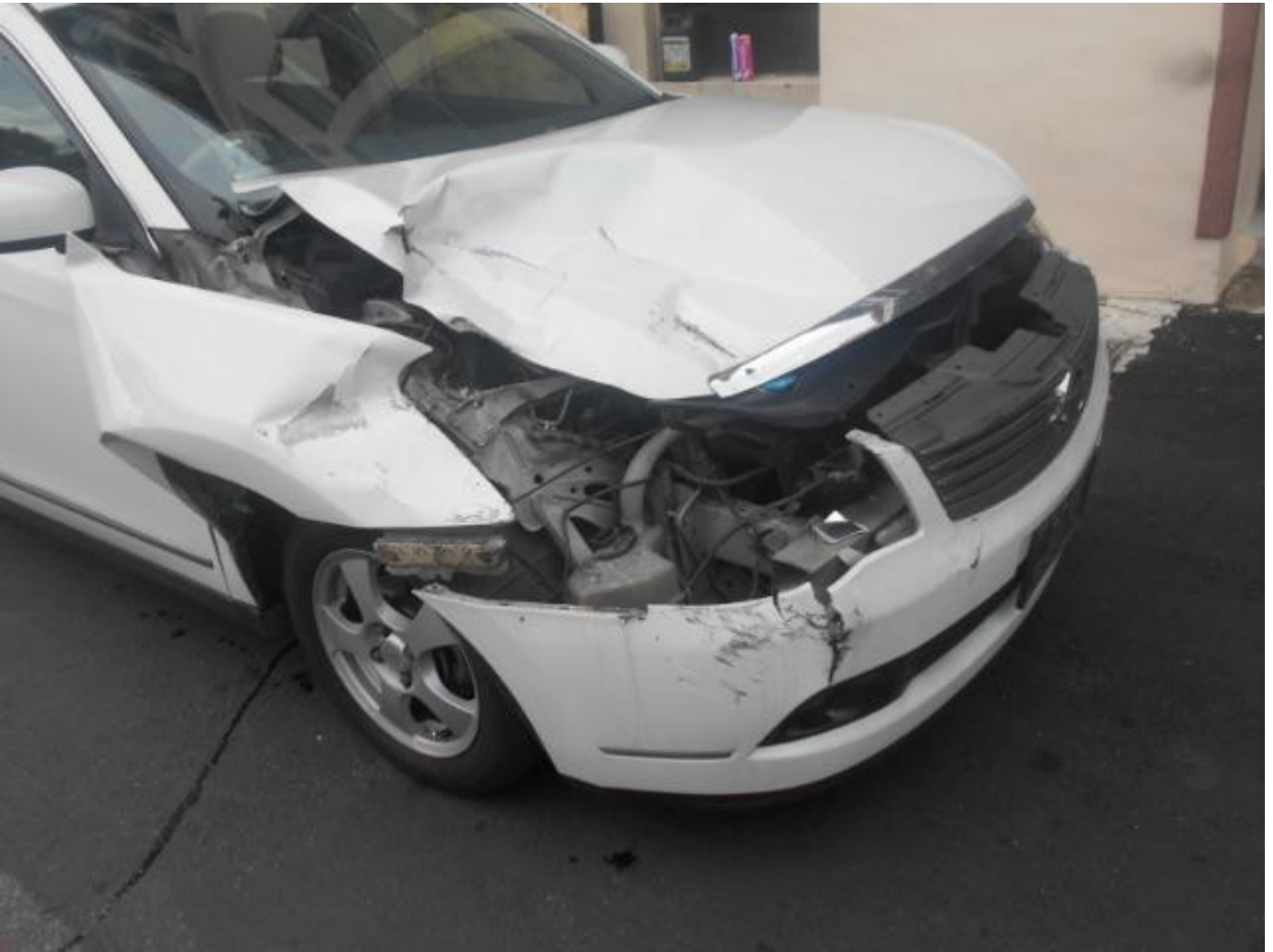
