According to our surveyor, the repair cost advised at \$15K-\$20K was based on our surveyor's estimate earlier marking before repair without supplementary. The final report we submitted at repair cost \$28,998.80 included supplementary items \$11,950.70 and some parts found damaged after dismantling and consistent to the accident.

We are unable to advise the book value due to the repairer did not provide although we had requested it several times and at the time of inspection.

The taxi is likely to be still within economical repair as this is about 1 year 9 months old taxi at the time of accident.
