

While waiting to make a U-turn, vehicle SPD2901T was on Lane 3 of Upper Changi Road North (4th vehicle), this lane can be turned left or proceed straight. My vehicle was stopped and this vehicle swerved passed me and vehicle plate was dropped and right side front of the bumper was dented due to the impact. The vehicle SDD 2901T was scratched on the side of the vehicle and paint marks were also found on the sport rim of the car.

Vehicle SPD 2901T was travelling on fast speed pertaining to above.

In addition to above, I had checked that no cars were approaching and the vehicle SDD 2901T just dashed towards my vehicle and caused this accident.
