Brief Details.

When my car came to a stop, an impact came from my rear. I realized that a Mini Bus bearing vehicle registration number, PA8365A (referring as V1) collided onto the rear portion of my car. Subsequently V1 drove off. There was no injury or government property damaged.

I was attended by the traffic police who advised me to lodge a traffic police report on that day.

Due to this accident, I was granted with medical leave (3 Days) after seeing a doctor.
