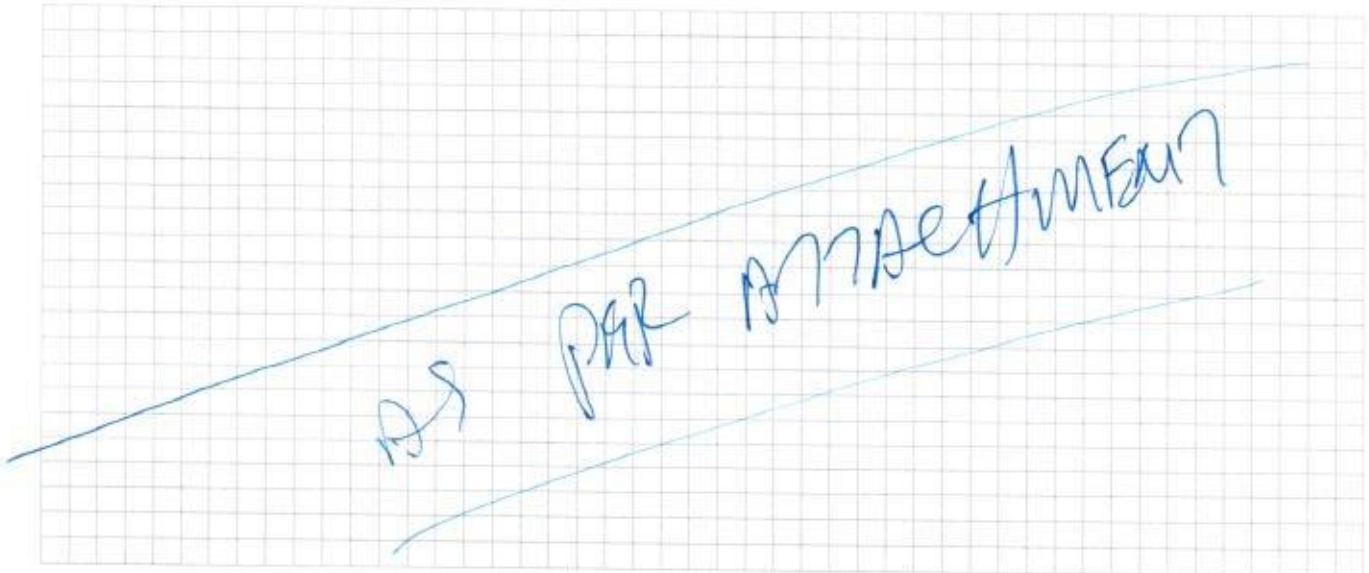

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving on Lane 3, the slowest of 3 lanes on Alexandra Rd. Suddenly a Red Jaguar drove (from lane 2) into my lane and brushed the front right of my car and then continue to drive off in my lane before swerving out to lane 2 again.
I chased after the car to a red light. We exchanged numbers and communicated via sms and whatsapp over next few days (see attached screen shots of messages) with the intent to settle privately. However, on the evening of 30 Apr. one day before the public holidays, she asked me to claim insurance for the damage.

Description of Incident

I was driving on Lane 3 (slowest lane) on Alexandra Rd on the day of the incident on a rainy afternoon. A red jaguar suddenly swerved into my lane at a sharp angle and very quickly, effectively squashing me to the kerb on the left. As a result, I had to apply an emergency brake into order to avoid a major collision which would hurt me (the driver) sitting on the right of my car. After driving into my car and lane, the jaguar continued on lane 3 before switching out to lane 2 again. At no time did the driver attempt to stop her car. Eventually I caught up with the driver of the jaguar who stopped at the red light.

Attached is a video clip of the incident. The sudden cutting into my lane and brushing against my car was a terrifying experience as i felt i was in danger of being squashed between 2 cars, sitting on the driver's seat in the front right. i also had no room to escape as i was driving on the innermost lane which is next to the kerb and pavement.

At first the driver claimed she did not know of her dangerous driving act but she apologised and we managed to exchange personal details. Over the course of the week through message exchange, i was led to believe we would settle privately but, the driver changed her position suddenly on the night of 30 April and said i should make a formal report (attached are the screen caps of the exchange) which led to this delayed formal report.
