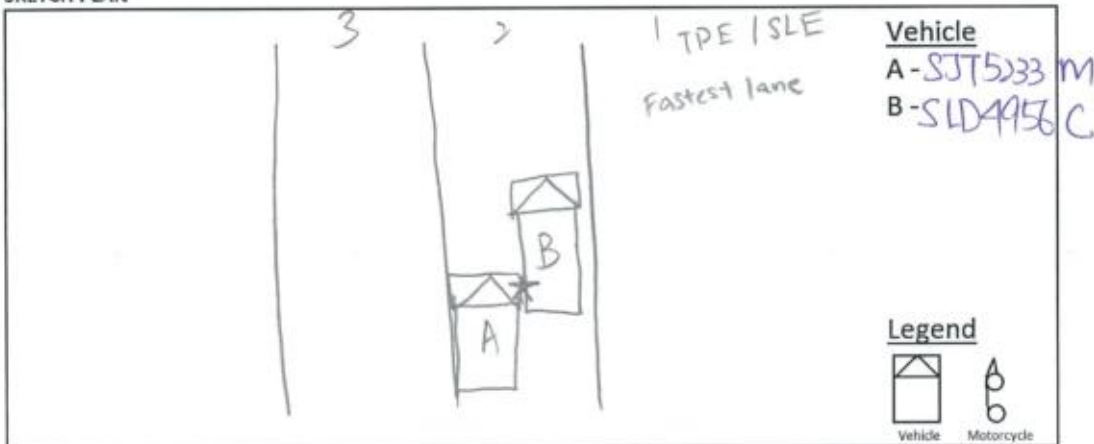

## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Incident took place at TPE Highway exit near Tampines Street 45 Blk 497J towards Punggol, exact coordinates (1.362977, 103.958438). I was the driver at that time and was heading home from Tampines therefore taking that route. As I was entering the highway, I signalled right and cut slowly to the right. After I successfully cut into the third lane, I aimed for the second lane while my right signal is still on. At this point of time, I looked into my right mirror and ensured that there's no car behind and went ahead to cut into the lane. Out of the sudden, a car cut left into second lane from the fastest lane and I was unable to react in time to prevent collision. And, I would like to point out the fact that the other driver was still driving at high speed while cutting into second lane. Therefore, this created an incident to happen.
