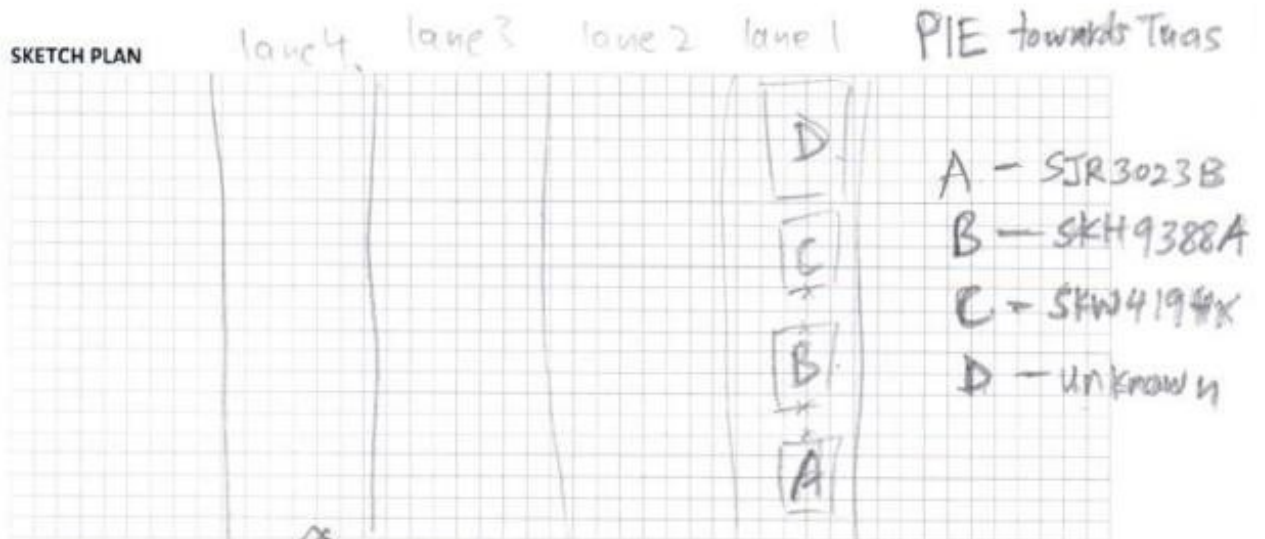

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I saw sudden break by vehicle SKH9388A at the front and tried to brake to avoid collision. My car still did not manage to avoid the hit. Vehicle SKH9388A has slide damage on the rear and for my car SJR3023B, there is quite substantial damage to the front.

I'm willing to claim responsibility to the ^{rear} damage from SKH9388A but I do not believe the damage from SKW4194X is caused by my car.
