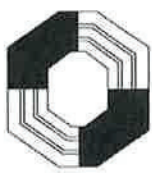

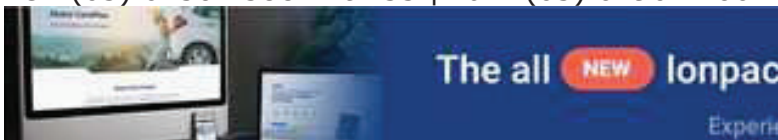

We refer to the above matter.

We have highlighted to your good office on 06/05/2019 of Third-Party's request to do Direct Settlement with our Principal, Lonpac Insurance Bhd.

Insured alleged no collision with the third party vehicle. However, Third party driver alleged head to rear collision and said that Insured told him to claim insurance and he has passengers who are willing to be witness.



We have tried calling the passenger's number to confirm but our calls was unanswered. Third party does not have any other supporting evidence (i.e. police outcome/accident video).

Based on the damage profile, we noted that there is damage to the rear of the taxi and we opine that it is consistent with the accident version and opine that BOLA 27 is applicable.


