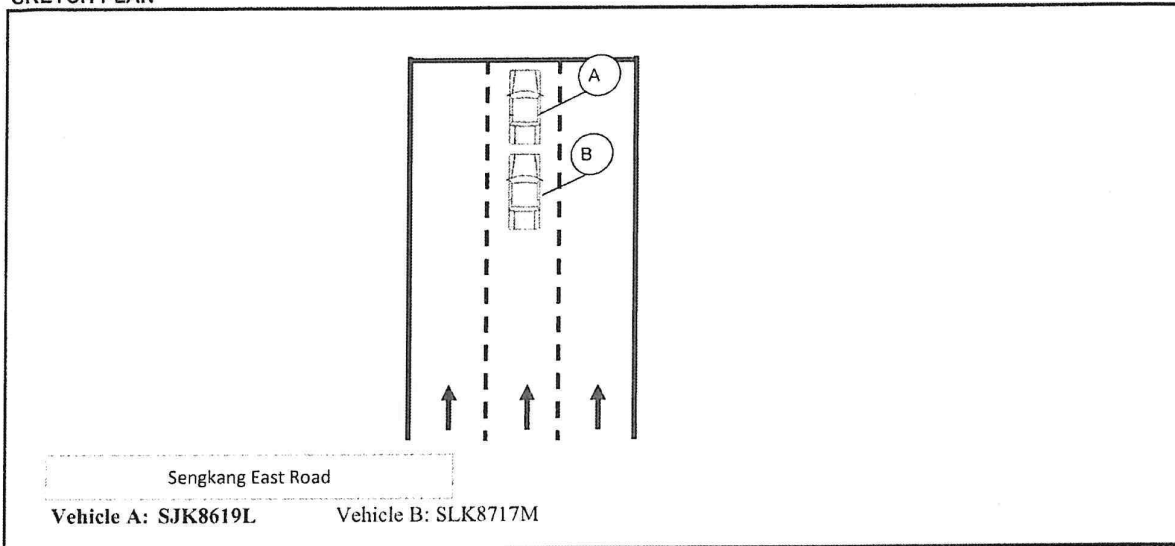

SKETCH PLAN

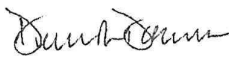
