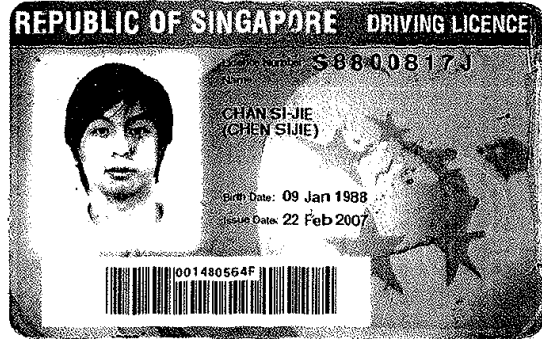

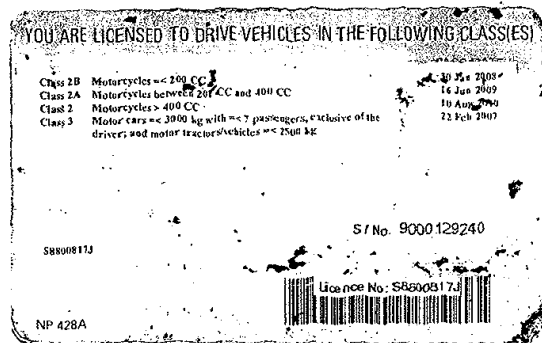

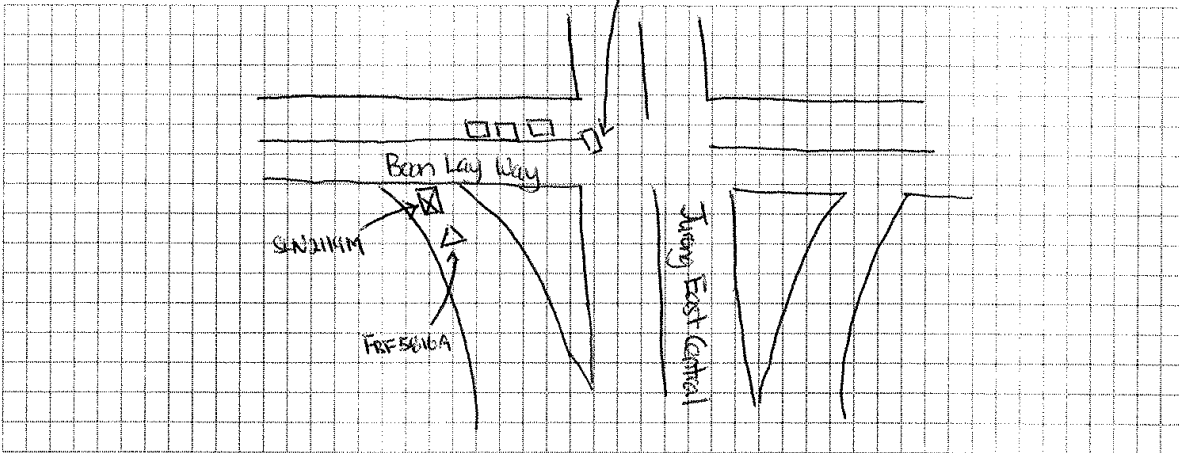

As I was proceeding my way in the filter lane, I noticed the traffic light had turned Red and vehicles on the major road could proceed to do their u-turn. However at that moment, as the traffic light had only just turned Red, cars have not moved to do the u-turn. The vehicle in front of me, SIN 2111M had started moving with intention to exit the filter lane. I then proceeded accordingly and checked the traffic and blind spot on my right. As I turned back my head, the collision occurred. There was more than sufficient time and space for the said vehicle to proceed and I believe that he had stopped for no apparent reason which caused me to collide to his rear right. I was travelling at a slow speed at that very moment.



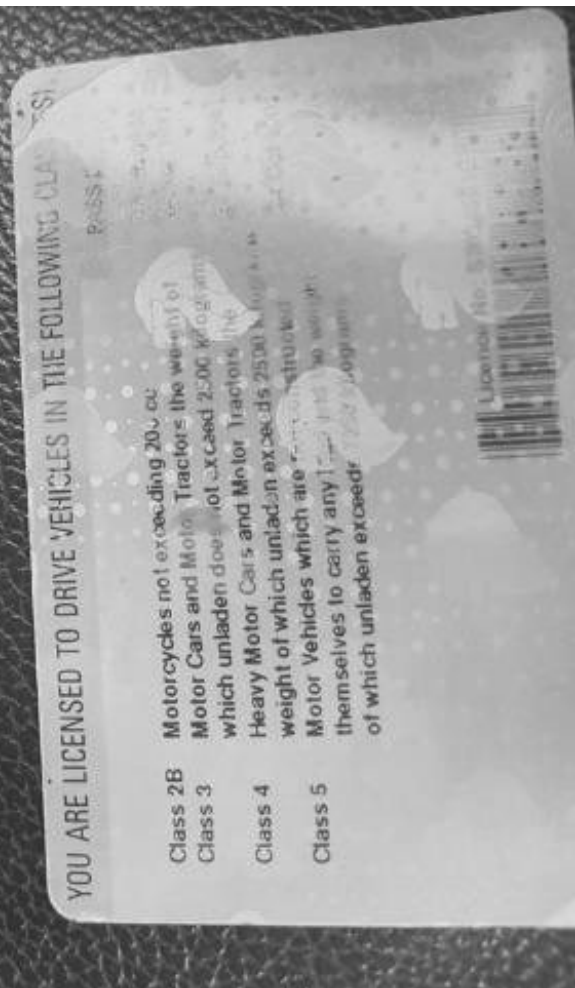
