We have reviewed the video.

From the video, we noted that third party from the first lane overtook a row of cars that was stationary and changed back to the first lane but stopped as there was another vehicle (i.e. SKC5921M) that had changed lanes from the third lane to the third party's lane.

We append below screenshots from the video on the other vehicle (i.e. SKC5921M) :-









We also noted that collision occurred when Insured driver had also changed lanes and had head to rear end third party vehicle.

As such, we opine that the liability is down against our Insured for front to rear collision and that the accident does not seem to be staged.

However, we would suggest to bring in the vehicle SKC5921M as a contributor to the accident as it had stopped at the right lane after dangerously cutting across the three lanes which caused the third party to also stop leading to the accident.

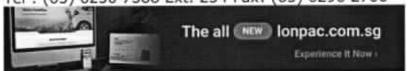

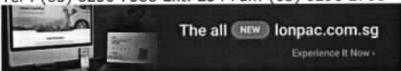
