- Total: \$4,161.15

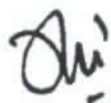

This Hiring Agreement is made between APEX Car Rental Pte Ltd (hereinafter referred to as "the Owner") and the Hirer whose particulars and signature appear overleaf (hereinafter referred to as "the Hirer") and subject to all the terms and conditions herein provided.

1. Commencement of Hire will be on the date and time the Hirer takes delivery of the Vehicle.
2. Unless the Hirer notifies the Owner and state the same in the Vehicle Check-In/Check-Out Form any defects to the Vehicle at time of the delivery the Vehicle shall be deemed to have been delivered and accepted by the Hirer in good repair and working condition with all fittings, accessories, tools, full petrol tank and spare tyre.
3. At the end of the Hire period, the Vehicle shall be returned by the Hirer to the Owner in the same condition as was delivered. The full cost of all damaged and missing items will be borne by the Hirer and payable in full.
4. The Vehicle may only be driven by the Hirer or by the persons who have been expressly designated and authorised in this Agreement. There shall be no insurance coverage for unauthorised drivers.
5. The Hirer confirms that he and any other persons authorised by the Owner to drive the Vehicle:
 - a. are between 21 and 60 years of age
 - b. holds a valid driving licence recognised under Singapore Law
 - c. has not less than 2 years satisfactory driving licence
 - d. do not suffer any physical infirmity or uncorrected defective vision or hearing
 - e. agree to take proper care of the Vehicle and to drive the Vehicle in a careful and skilful manner observing all traffic regulations and laws and to ensure that the Vehicle is properly parked and locked when not in use
 - f. agree that Vehicle will not be used for racing or speed trials, towing of other vehicles, carrying goods or passengers for hire or reward, giving driving lessons, and other illegal or immoral activities.
6. have been notified that the Vehicle can only be driven within Singapore. Please refer to Clause 6 and Clause 14.
7. shall not make any alteration, changes or remove any parts whatsoever from the Vehicle without the prior written consent of the Owner.
8. agree to protect the interest of the Owner and the Owner's insurance company in the event of an accident during the period of hire by:
 - i) obtaining names and addresses of parties involved and witnesses
 - ii) not admitting fault and liability to the accident
 - iii) immediately notifying the Owner of the accident
 - iv) giving a detailed report including an accurate diagram, even in the case of slight damage within 24 hours by filling in an Insurance Motor Report Form which is available at the Owner's premises
 - v) make a detailed Police Report including a diagram of the scene of accident within 24 hours of the accident **IF**
 1. any party to the accident suffered an injury as a result of the accident
 2. the accident involved a Government vehicle (MID or QX Registration Plates) and/or damaged to Government property (Road Divider/Fencing, Trees, Traffic Lights/Lamp Posts, etc)
 3. the accident involved a foreign vehicle (Malaysian Vehicle or Embassy Vehicle)
 4. the accident involved a pedestrian or cyclist (even if the pedestrian or cyclist was not injured)
9. **IT IS AN OFFENCE IF A POLICE REPORT IS NOT MADE UNDER THE ABOVE CIRCUMSTANCES.**
 - w) supply a copy of the Police Report and such information and assistance in connection with the accident as the Owner or its insurers may require
10. have been notified that the Vehicle will not be insured after the agreed return date and/or date on which advance rental paid expires. The Owner must be notified of intended extension of rental at least 2 hours prior to expiry of rental and payment for the extended rental must be made to the Owner within 24 hours. Failure by Hirer to comply will leave the Owner with no alternative but to treat the matter as a fraud/theft case and a police report will be lodged forthwith.
11. The Vehicle has been insured for Singapore use only to cover:
 - a. all Third Party risks and liabilities as required by Singapore Law
 - b. all damage to Third Party property
 - c. damage to Vehicle (subject to Clause 7 below)
 - d. loss or theft of Vehicle.
12. In the event that the Vehicle or any part thereof is damaged as a result of any accident, the following will apply:
 - a. The Hirer shall forthwith pay to the Owner that Excess amount in respect of each and every accident regardless of whether the Hirer is at fault:
 - b. Only upon the Owner being able to claim the full cost of the damage to the Vehicle against the third party involved in the accident or the third party's insurer, will the Excess amount paid by the Hirer be refunded back to the Hirer.
 - c. The Hirer also agrees that the Owner may in its absolute discretion conduct any negotiations and effect any settlement with the insurers and agrees to abide by any such settlements.
 - d. In the event of any damage and loss to the Vehicle caused by negligence and/or contravention of any statute or regulations by the Hirer or his authorised drivers which result in the insurers repudiating liability for such damage and loss, the Hirer shall be liable for all damage to the Vehicle (including loss of use) and shall indemnify the Owner against all costs, claims and liabilities arising out of such negligence or contravention.
 - e. Further to Clause 6.c. above the Hirer may elect to partially waive the first Excess amount (specified overleaf) in respect of any single accident with the payment of an additional Collision Damage Waiver fee as specified overleaf. The partial waiver of Excess is expressly subject to and conditional upon the following:
 - a. Damage to the Vehicle (even for slight damage) resulting from each and every accident must be reported to the Owner and Police within 24 hours from time of accident. A copy of the Police Report must be given to the Owner.
 - b. Damage to the Vehicle was not the result of negligence and/or the contravention of any statute or regulation by the Hirer or his authorised drivers.
 - c. The Hirer's agreement to pay to the Owner the Non-Waivable Excess amount as specified overleaf.
 - d. Non-collision damage to the Vehicle (e.g. Vandalism and/or missing items) are not covered by Collision Damage Waiver.
13. The Hirer shall pay to the Owner:
 - a. rental for the Hire of the Vehicle at the rate specified overleaf
 - b. the Collision Damage Waiver, Personal Accident Insurance and Malaysia Use fees where applicable
 - c. additional rental charges calculated at one-fifth the daily rate for each overdue hour for the return of the Vehicle
 - d. the Owner's estimated fuel consumed by the Vehicle if the Hirer returns the Vehicle with less than a full tank of premium grade petrol
 - e. all other sums which may become due and payable under this Agreement
14. The Hirer shall be responsible for and shall indemnify the Owner against all fines, penalties, summons, court expenses or any other legal imposition in respect of the Vehicle and the Driver of the Vehicle during the period of hire.
15. The Owner shall at its own cost provide a 24-hours Breakdown and Towing Service to the said Vehicle within Singapore only. Punctured tyre, empty petrol tanks and/or misplaced Vehicle keys do not constitute a breakdown and the Owner is not obliged to attend to such cases. In the event that the Owner attend to such cases, the Hirer will bear the cost of \$850.00 for each and every case.
16. The Owner shall provide the Hirer with a Replacement Vehicle (within Singapore only) of similar capacity subject to the following:
 - a. that the damage/loss caused to the Vehicle was not the result of the deliberate act/omission/negligence and/or contravention of the terms and conditions of this Agreement and/or any statute or regulation by the Hirer or his authorised drivers.
 - b. the Hirer's acceptance that the Replacement Vehicle will be subjected to the same terms and conditions of this Agreement.
17. Further to Clause 5.g. above, if the Hirer drives the Vehicle into Malaysia without our company's authorisation and if the Vehicle encounters an accident or breakdown, then the Hirer shall be liable for all the resultant costs (total cost of repairs and/or loss to the Vehicle, all claims and costs associated with third party personal injury claims and property damage, all costs to recover and tow the Vehicle back to Singapore, and loss of rental income suffered by the Owner whilst the Vehicle is undergoing repairs).
18. No condition warranty or stipulation of any kind is given by the Owner in respect of the Vehicle and the Owner shall not be held liable for any injury and/or loss of any kind whatsoever suffered by the Hirer and/or any third parties as a result of the Vehicle or any part of it being unusable/faulty out of order or unseizable.
19. In the event of any breach of this Agreement by the Hirer, the Owner will without prior notice to the Hirer resume possession of the Vehicle and for this purpose the Hirer hereby irrevocably authorises the Owner by its agency and servants without notice to enter any premises in which the Vehicle may for the time being be kept and to take possession thereof without being liable for any action or proceeding at the suit of the Hirer or any person claiming under or through him.
20. No relaxation forbearance delay or indulgence by the Owner in enforcing any of the terms of this Agreement or the granting of time by the Owner to the Hirer shall prejudice affect or restrict the rights and powers of the Owner hereunder nor shall any waiver of any breach hereof operate as a waiver of any subsequent or continuing breach thereof.
21. This Agreement shall be governed by and construed in accordance with the laws of Singapore and the parties agree to submit to the jurisdiction of the Courts of Singapore.
22. The Vehicle Check-Out/Check-In Form is an integral part of this Agreement.
