

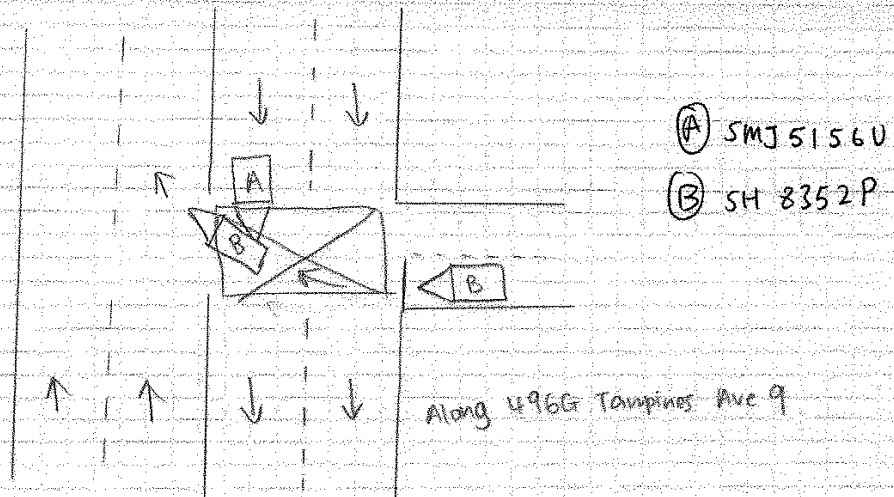

I was in full control of my car.

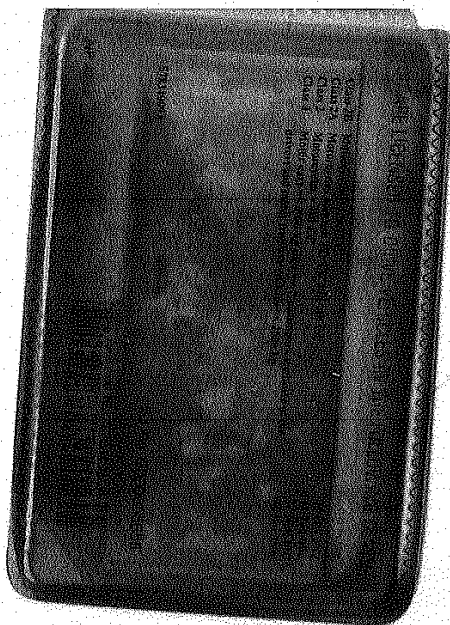
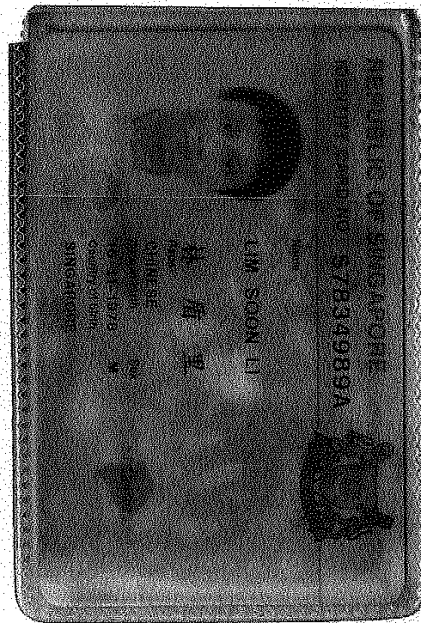
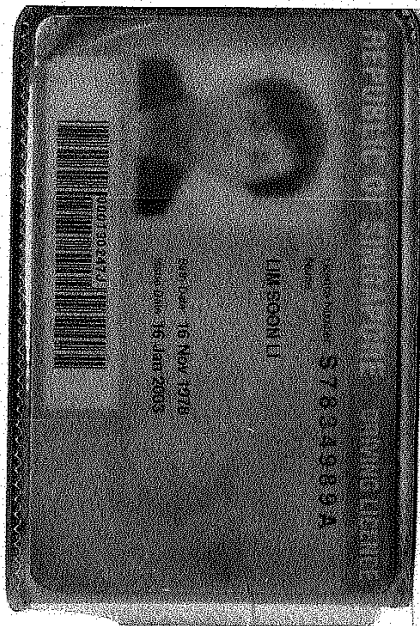
