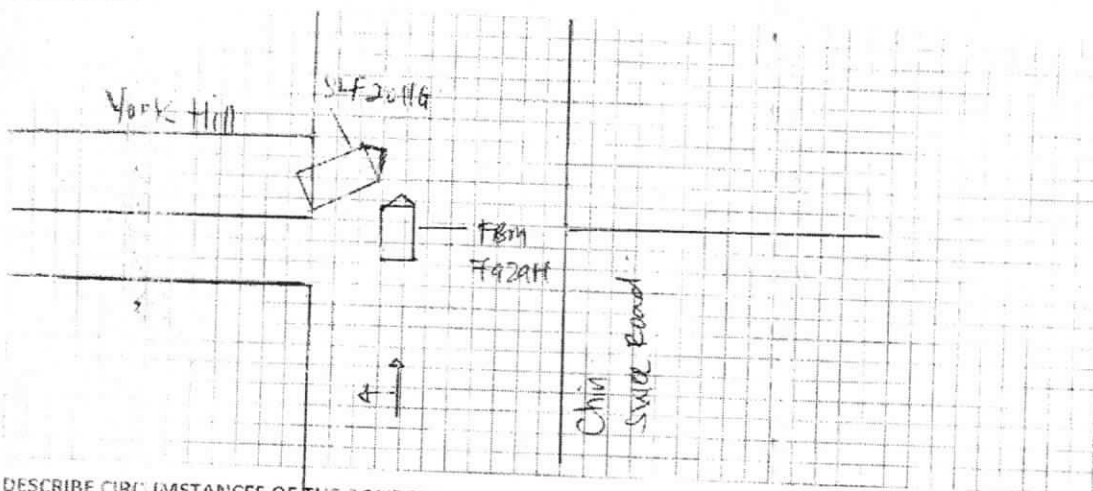

Brief Details.

Traffic police and ambulance then came down shortly and I then conveyed to SGH and given 4 days MC for my injury.

I was driving straight and had the right of way while the car suddenly drove out of his stop line which I do not know why also. My motorcycle also sustained slight damage from the accident. After discharge from hospital, the TP IO asked me to lodge a police report.
