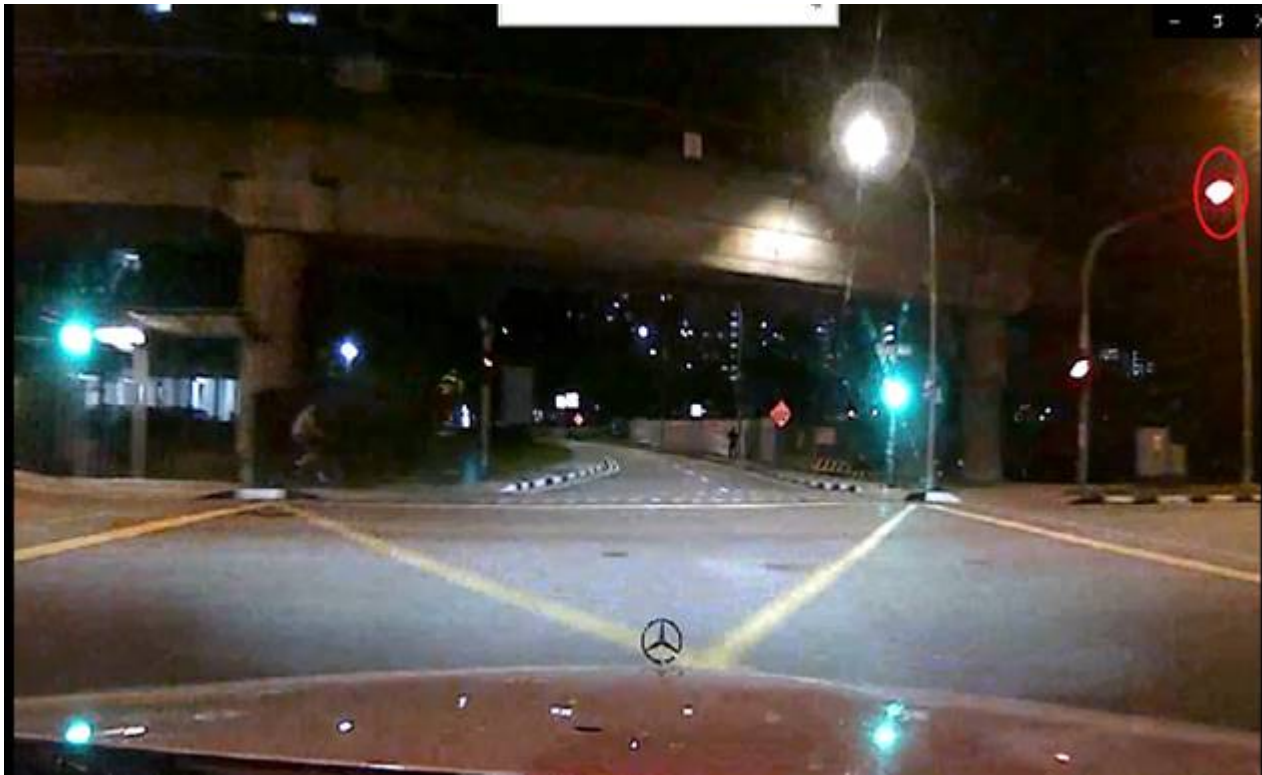

ROAD TRAFFIC ACCIDENT INVOLVING VEHICLE NOS. SLK 1595T AND SHA 7503U ON 01/05/2019

We refer to the above matter.

We have reviewed the circumstances of the incident and we are of the opinion that your driver is more liable by beat traffic light. This is evidenced by print screen photos from our insured driver.





Below is a copy of our insured's accident report statement for your perusal.

Brief Details.

On 1/5/2019 at around 0200hrs, I was driving my white Mercedes Benz taxi (SHA7503U) straight along Lorong 3 Geylang towards Upper Boon Keng Road. At the cross-junction of Lorong 3 Geylang and Sims Avenue, as the traffic light was green in my favour, I continued to go straight. However, at the same time, there was a champagne-coloured Honda Vezel (SLK1595T) that was going straight as well and it collided with my taxi (SHA7503U) on the front left side bumper. This resulted in my front bumper and front bonnet shifted, left headlight glass broken, some scratches at the front and license plate dropped off.

After the collided, both cars came to a stop. I felt dizzy and numb and did not step out of my car (SHA7503U). I was ferrying a passenger at that time who is also my witness. He was not injured. Shortly after, the ambulance and traffic police came. I was conveyed to Tan Tock Seng Hospital for outpatient treatment. I am not sure exactly of the damage of the other car (SLK1595T) or if the driver or passengers were injured, and he shifted his car to the side of the road after that.

My taxi (SHA7503U) has a in-car camera and I have handed my memory card to the traffic police and was handed an acknowledgement slip.

In view of this, we regret to inform you that we are unable to look into your claim.

We will now close the matter in our end.
