May I seek your assistance to perform a detailed mechanical inspection of the 43 vehicles below:

a) Case IAFP-IB-20190405 - Mechanical Inspection of Mini Bus, PC1978S (TP/IP/54999/2018)

On 26 September 2018 at about 5.45 p.m., it was revealed that the Accused was driving his mini bus and was travelling along the bus lane along Woodlands Avenue 3 towards Woodlands Avenue 5 when he colliding onto the Deceased, who was crossing at the signalised pedestrian crossing. As a result of the accident, the Deceased was conveyed in a critical condition to Khoo Teck Puat Hospital. On the same day, the Deceased succumbed to his injuries and was pronounced dead in hospital at 6.31 p.m., by the Dr Ashley Yuen.

b) Case IAFP-IB-20190405 - Mechanical Inspection of Motor Car, SKU9165H (TP/IP/67555/2018)

On 7 December 2018 at about 8.30 p.m., the Involved Party was driving his motorcar, SKU 9165 H and was overtaking a stationary bus on the left of the 2 lanes of Petir Road towards Upper Bukit Road and was travelling behind the Witness on the right lane. After passing the stationary bus, the Involved Party was switching back to the left lane when he collided onto the Deceased, who was crossing from his right to left, ahead of the Witness. Due to the collision, the Deceased landed on the right lane, ahead of the Witness's motor car. The Deceased was reported to be unconscious and was conveyed to the National University Hospital however, the Deceased succumbed to his injuries and was pronounced dead at 10.04 p.m. by Dr Shao Hong in hospital.

On 17 January 2019 at about 7.08 a.m., based on the video footage retrieved from FIR caller, the Involved Party was driving his motorcar, SKB 3467 B and was travelling along the right bend of Choa Chu Kang Way towards Sungei Kadut Drive, before Choa Chu Kang North 5, on lane 1 of the 3-lanes. At this juncture, the Deceased was seen running from the Involved Party's right side to left side. At the same time, the Involved Party was seen making a lane changed from lane 1 to lane 2 and subsequently made an abrupt lane changed back to lane 1. From the video footage, it is unable to ascertain if the Deceased did walk backwards to the centre divider. As a result of the accident, the Deceased was bleeding from his mouth and he sustained head injury thus he was conveyed by an ambulance in an unconscious state to Ng Teng Fong General Hospital. However, on the same

day at 8.09 a.m., the Deceased had a traumatic arrest and he succumbed to his injuries. He was then pronounced dead by Dr Ashvin Vardza Raju in Ng Teng Fong General Hospital.

The Accused started driving off along Jurong West Avenue 5 and made a left turn onto Jurong West Street 82 towards Jurong West Street 81 when the front left portion of the motor bus collided onto the Deceased whom was cycling across from the downslope pavement straight onto the signalised pedestrian crossing at unknown pedestrian signal. Upon collision, the Deceased fell to the road and was ran over by the left front and rear tyres of the motor bus. As a result of the accident, the Deceased sustained head injuries. He was pronounced dead at scene by paramedic Sidika at 8.35 a.m.
