w) Case IAFP-IB-20190405 - Mechanical Inspection of Motorcycle, JQR1865  
(TP/IP/06877/2019)

On 4 February 2019 at about 1953 hrs, the motorcycle, JQR1865 was travelling straight along Jurong Island towards End on lane 2 of 4 lanes road when the pedestrian (deceased) walked across the road ahead of the motorcycle, from rider's left side to right side. The motorcycle tried to avoid the pedestrian however was unable to do so timely, thus collided into the pedestrian. Due to the collision, both were conveyed by an ambulance to Ng Teng Fong General Hospital. However on 8 February 2019 at 12.55 am, the pedestrian succumbed to his injuries and he was pronounced dead in the said hospital.

On the 22 March 2019 at about 11.38 p.m., B1 was travelling on lane 4 of 4 along Bukit Timah Expressway (BKE) towards Woodlands Checkpoint, exiting from the slip road of Kranji Expressway (KJE), when B1 made a lane change to the right into lane 3 and side swiped A1, who was travelling on lane 3 of 4. As a result of the accident, A1 was critically injured. A1 was sent to Khoo Teck Phuat Hospital, where he was reported to be unconscious with head injuries. B1 was pronounced dead at 0654hrs hrs by Dr Amanda Choo.
