



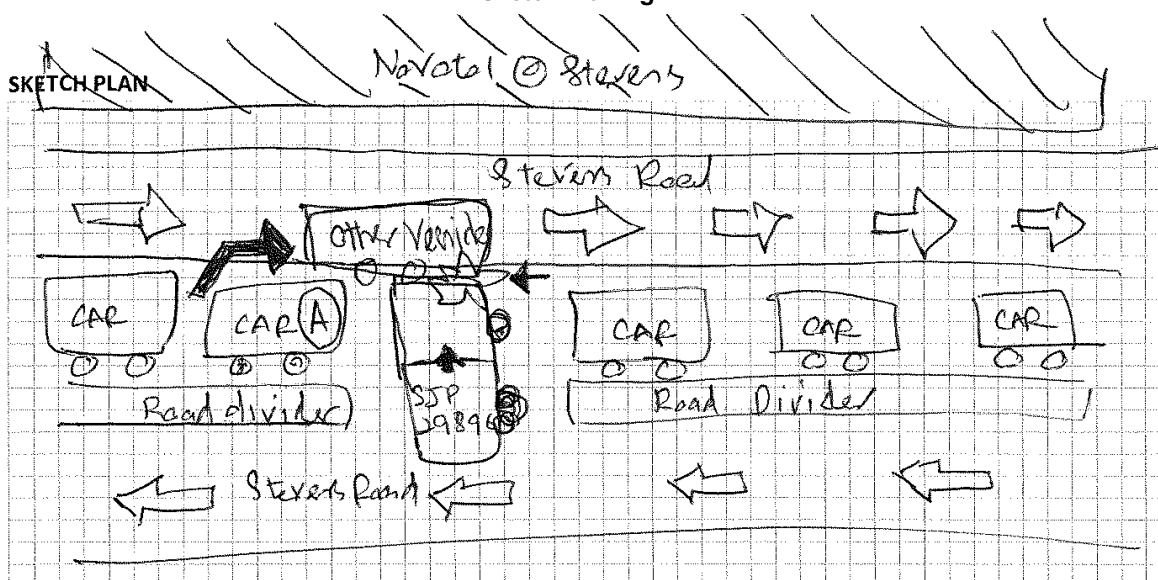

## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 9/5/19, at approximately 6:35 pm, I was trying to make a U-turn along ~~the~~ Stevens Road at Navotal @ Stevens.

The lane I was turning into was a 2-lane road, and the first lane was full, so I had to ~~not~~ drive forward to see beyond the car blocking my view.

The other car, SLV 2477 L, was being blocked by CAR (A), and he was in a rush, so he changed lane and tried to pass CAR (A). As I was in front of CAR (A), he sped out from behind CAR (A) and he swiped me in the front of my car, causing scratches, dents and my license plate to fall off.

my car was in front of CAR (A), perpendicular. It was stationary because I was waiting to get a clear path. Therefore, SLV 2477 L drove out too fast, and the driver caused ~~the~~ car to swipe in front of mine.
