Based on the video footage, we are of the view that liability is against CB6841D.

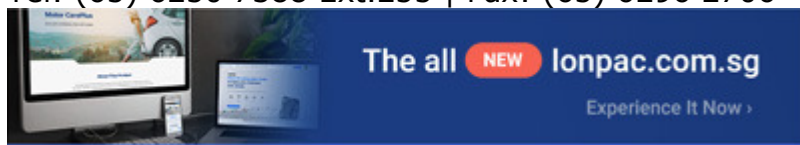
