## **Brief Details.**

On 12/05/2019 at about 2110hrs, I was driving my Malaysian vehicle bearing registration number JPP997 along Upper Thomson Pool to the second and nothing was along Upper Thomson Road towards Sembawang road on the 2nd lane of a 3-lane road and nothing was amiss. There were 3 other formals

amiss. There were 3 other female passengers in my vehicle.

On the same day at about 2115hrs, I noticed that there was a Mercedes vehicle bearing registration number SER6883V married and the same day at about 2115hrs, I noticed that there was a Mercedes vehicle bearing registration number SFB6883Y moving in front of me. Not long after the said vehicle suddenly performed an emergency brake. As such that there was a Merceues vehicle suddenly performed an emergency brake. During that instant I then felt a collision for instant I then felt a collision from my rear. Hence I went out to make a check. It was then I discovered that my there was a Levil viction. my there was a Lexus vehicle bearing registration number SGG6000R moving on my rear had collided onto my rear portion of walking my onto my rear portion of vehicle. The said collision had caused my vehicle to inched forward resulting my

front portion of vehicle to collide onto the said Mercedes rear portion of vehicle.

Upon further observation, I noticed that it was a chain collision involving two other vehicles, a Toyota vehicle bearing registration number SKV549M and a BMW vehicle bearing registration number SMF808B. There was a fallen object ahead and hence the Toyota vehicle (SKV549M) had applied emergency brake. And due to that the rest of the vehicles including mine got affected resulting to a chain collision. One of my passenger Teo Geok Choo (NRIC: S1638434H, Hp:98938896) called for ambulance as she felt giddy due to the accident. Not long after ambulance and Traffic Police attended to scene. No one was conveyed. There is no in-built CCTV installed in my vehicle. There is no CCTV at the said location. I wish to state that my vehicle front and rear bumper were dislodged and suffered several dents. My

vehicle was then towed away. On 13/05/2019, I went to seek further medical attention as I felt pain on my rear neck. I was given 5-days medical leave while two other passengers also had gone to see doctor and was given 5-days medical

As such I am making this report for amendments vide T/20190513/2001 as instructed by TP IO.
