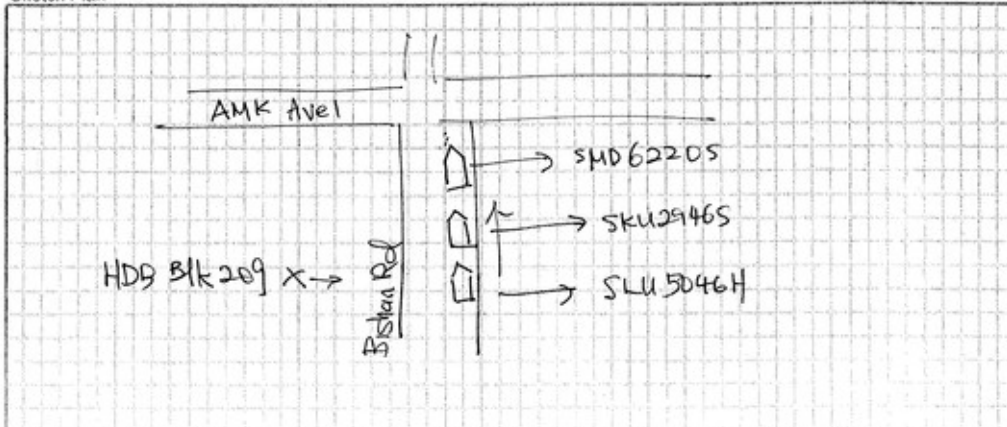

Describe Circumstance of the Accident

Date : Mon 13 May 19
Time : around 6:30pm

Travelling along Bishan Rd towards AMK Ave 1. Traffic light was red at junction of Bishan Rd/AMK Ave 1. Stopped behind SMD 6220S.

Stationary and waiting... was banged into from behind by SLU 5D46H. My car lurched forward and hit SMD 6220S.

Set car to park and came out to inspect vehicle. Observed following:

SMD 6220S, rear bumper above second S, crack lines in paint, around half finger length

SLU 5D46S, rear bumper, 2 holes where impact occurred

SLU 5D46H, front licence frame broken.

Condition of road:

Natural lighting clear

No rain

Road was wet from earlier rain

Traffic heavy but not congested.

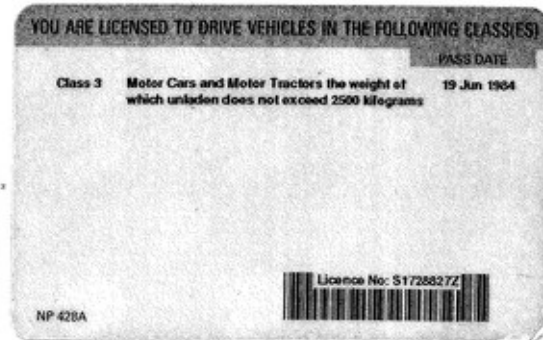
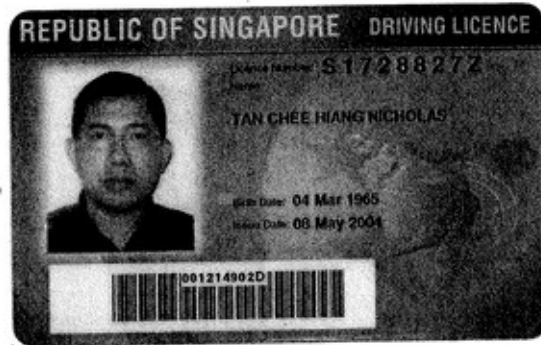
