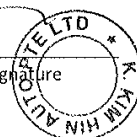

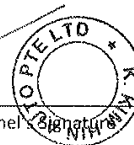

Brief Details.

It was about 11.05am on 12 May 2019 (Sunday). I was exiting Sentosa and was driving straight on the extreme right lane towards the Keppel tunnel along the Sentosa Gateway (towards Telok Blangah Road) 14/1F.

As I approached the tunnel, a car suddenly came out of the opposite direction on the right side and made a u turn.

I jammed my brakes but could not stop in time. My car hit the passenger side of the other car (a navy blue MPV SJU 1697D. There was no passenger in the car other than the driver)

I got down the car to speak with the driver. I saw her seated in the driver seat and knocked on her window to signal to her if she could wind down the window to talk.

She wind down and said she could not speak then as she was in shock.

So I comforted her to remain in her seat while I went back to my car to get my phone.

When i went back the second time round, the driver was calling GRAB service. That was when i asked if she was a GRAB driver and she nodded. So i went back to my car to call my friend to inform him that I met with an accident. While I was calling, AETOS personnel knocked on my car window to asked if I was ok. I was very pleasantly surprised at the speed they arrived at the accident scene and assured them I was ok. I told them to check on the other driver as well, which they did.

They came back to my car to inform that the other driver required medical assistance and they have summoned for an ambulance.

I switched off the engine and the AETOS asked for my IC and driving license.

They informed me that as an ambulance has been called, we have to wait for the Traffic Police to arrive.

Very shortly after, the ambulance arrived, and the driver of the blue MPV asked to be carried onto the stretcher and was sent to SGH. She passed me a phone which the husband was on the line. I spoke to the husband and he informed me that he could not go to the accident site but would meet her later in the hospital, and that the car was a rented vehicle. She gave me her husband number so that I could follow up with them later. Soon the EMAS Tow truck also arrived.

Traffic Police (Sergeant Brandon) arrived shortly after the ambulance went off. He surveyed the distance and was soon joined by another Traffic Police (Sergeant Joey Png). EMAS towed the blue MPV away and I followed behind. We parked at the open air car park next to the old railway station.

There I was given a Case Card Report No. D/20190512/0057 to meet up with the IO Adelina on 13 May 2019 at 11.30am.

I followed up with a few more calls to the husband of the driver yesterday to check on her condition. The last time we spoke was on 13 May 2019 at 10.43am when the husband called and told me she went home yesterday. He shared with me that she would be on medical leave for 9 days and that she would follow up with another doc visit after that.

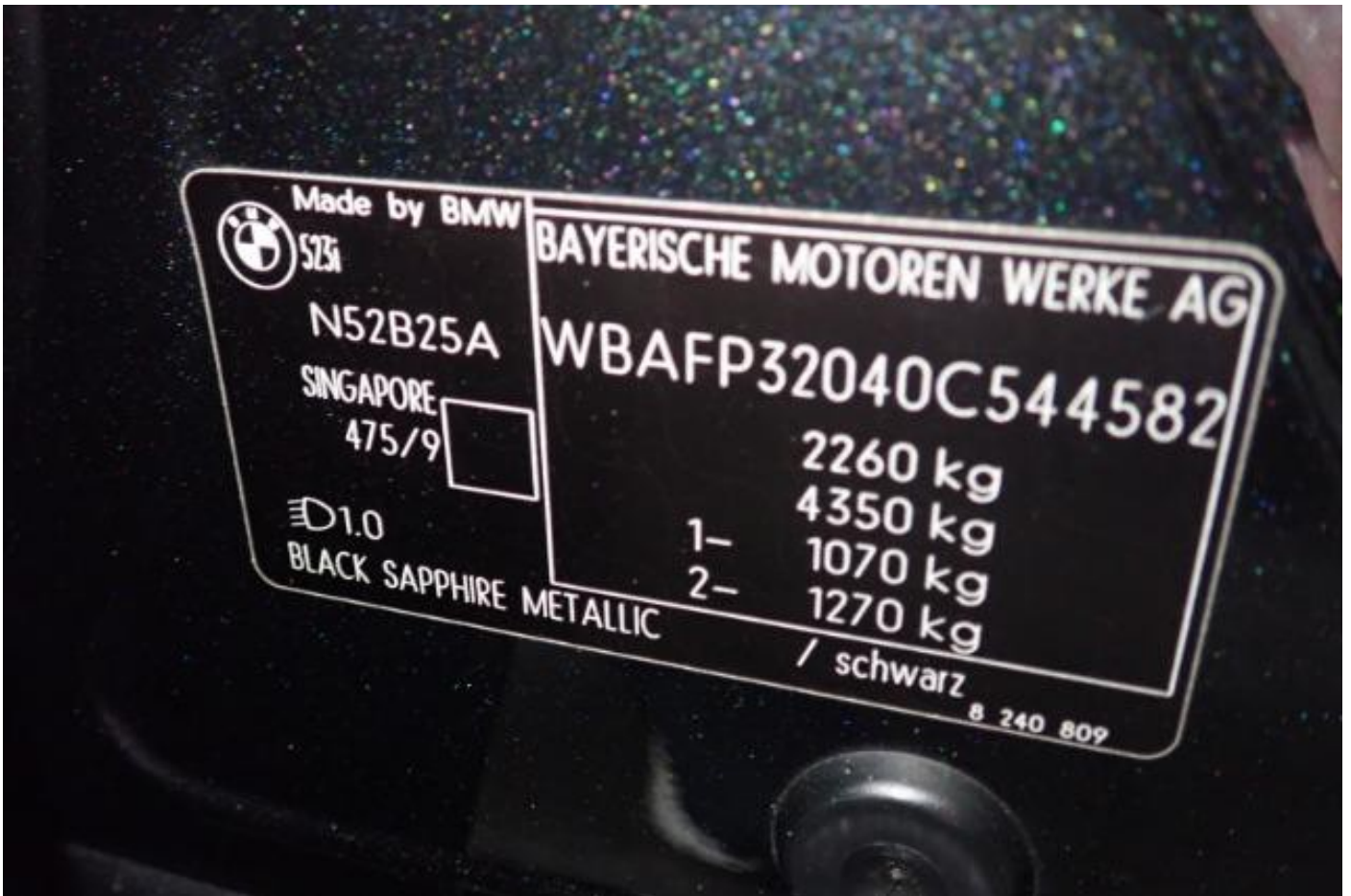
