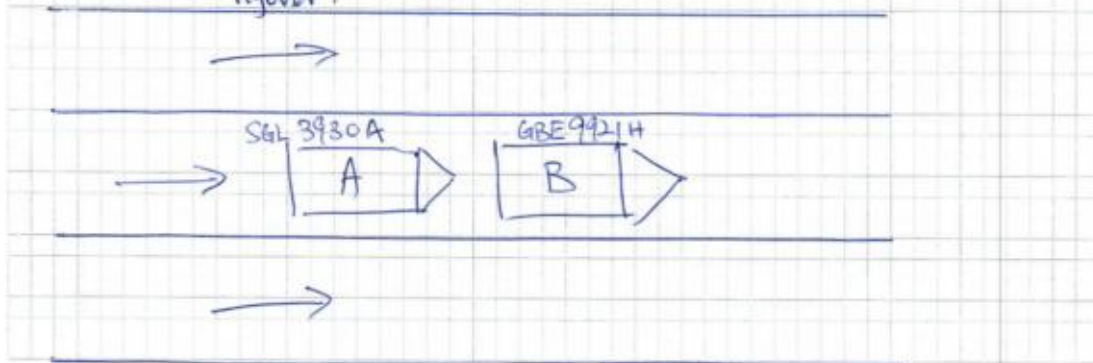
SKETCH PLAN
