

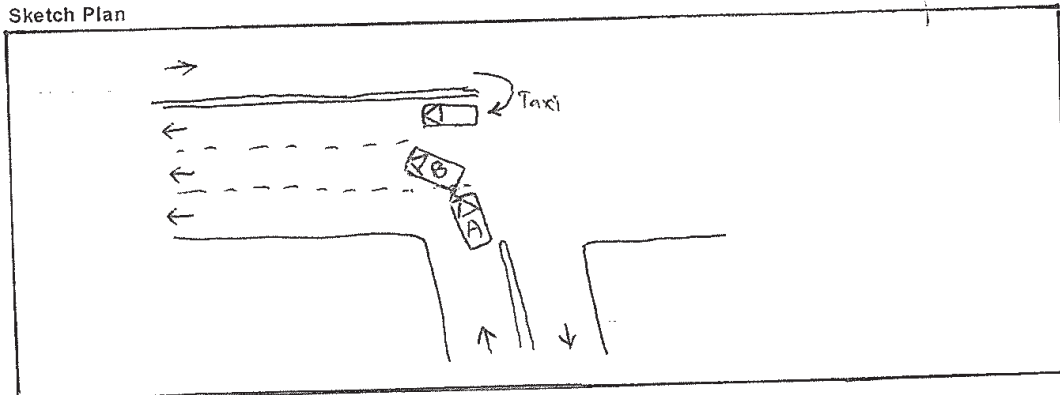

Describe Circumstances of the Accident



While I saw the car SLJ2937P was moving forward to turn left to Maulmein Rd, I also move forward behind his car not realised that the car SLJ2937P applied emergency ~~break~~ break to avoid collide with a Taxi (in blue) making U-turning from the opposite direction at that moment. I stop as the break but was too late to stop my car and knocked against the rear tailgate of SLJ2937P. The impact of the accident caused the front bumper damaged and front part of bonnet dented.

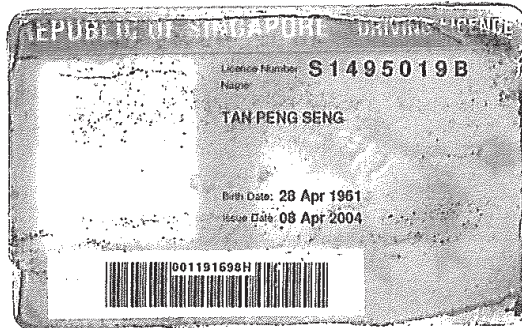

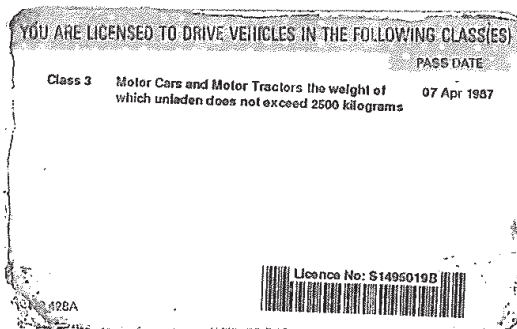
