Circumstances of Accident

I WAS IN LANE 1 ON PIE TUAS. THE TAXI (CAR B AS ABOVE) SUDDENLY CUT INTO MY LANE, AS IF HE WAS RACING, AT HIGH SPEED, AND HIT THE LEFT SIDE OF MY CAR. UPON MITRAL IMPACT, THE TAXI STILL CONTINUED TO DRIVE FORWARD IMPATIENTLY AND DID NOT CARE THAT I HAD A MOTHER WITH A YOUNG TODDLER ON BOARD. THANKFULLY WE WERE ALL IN SAFETY BELT AND THIS PROTECTED US FROM THE SHOCK. THE TAXI'S REAR RIGHT PASSENGER DOOR, REAR RIGHT WHEEL'S SPORT RIM, AND THE BODY AREA AROUND THE REAR RIGHT WHEEL WAS SCRATCHED AND DAMAGED. THE REAR OF THE TAXI WAS UNDAMAGED. AS FOR MY CAR, MY LEFT HEADLIGHT WAS SCRATCHED, WITH THE METAL AROUND IT DENTED, AND THE LEFT FRONT AREA OF MY CAR WAS DAMAGED. THE TAXI DRIVER'S LACK OF CONCERN AND CONSIDERATION FOR THE SAFETY OF OTHER MOTORISTS ON THE ROAD POSED A VERY SERIOUS AND HAZARDOUS THREAT. THE TAXI DRIVER ALSO RUSHED OUT OF HIS TAXI AND ARGUED AS IF HE WANTED TO BEAT ME. HE WAS ALSO NOT COOPERATIVE IN PROVIDING HIS DRIVING PARTICULARS AND WANTED TO HURRILY DRIVE OFF AFTER THAT.

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was in Lane 1 on R25 Tues. The taxi (car B as above) suddenly cut into my lane, as if he was racing, at high speed, and hit the left side of my car.

Upon initial impact, the taxi still continued to drive forward impatiently and did not care that I had a mother with a young toddler on board. Thankfully we were all in safety belt and this protected us from the shock.

The taxi's rear right passenger door, rear right wheel's sport rim, and the body area around the rear right wheel was scratched and damaged.

The rear of the taxi was undamaged.

As for my car, my left headlight was scratched, with the metal around it dented, and the left front area of my car was damaged.

"The taxi driver's lack of concern and consideration for the safety of other motorists on the road posed a very serious and hazardous threat.

The taxi driver also rushed out of his taxi and argued as if he wanted to beat me. He was also not cooperative in providing

his driving particulars and wanted to hurriedly drive off after that.
