ACCIDENT INVOLVING VEHICLES GX 6144U (OI) AND SJX 2742J (TP) ON 15/05/2019

We refer to the above matter.

It was reported that Insured vehicle reversed out from c/p lot when hit TP behind it.

We had spoken to the Insured Driver Mr Tan and was informed of the TP claim. A letter was sent out to the Insured company to notify TP claim and NCD issues. No feedback received till date.

As such, in view of BOLA 24, liability may not be to our Insured's favour and we have to settle the claim from the TP vehicle and the damages sustained to TP vehicle were consistent to the nature of the accident.


