

Account of Accident Involving SKS8455M & SCU9272B

At approximately 2.30pm on 19 May 2019, I was driving along West Coast Highway in the direction of Tuas in my sister-in-law's car, a Honda HRV SKS8455M.

I was travelling straight in the rightmost lane when I suddenly felt a jolt on the left. I braked and that is when I saw a car on the left.

The grey Peugeot SCU 9272B had drifted into the left of the car and collided with me. The collision damaged the front left body panel and left door. There were also scratches on the front left wheel hub and front bumper.

The driver, Ms Lee Mei Woon (IC S0139826A) apologised when we meet along the road kerb. We resolved that I will seek a claim for damages against her for the car I was driving.
