



In regards to 22 May 2019 incident, my dad, Mr Alan Khoack Yung will be representing me to submit this statement on my behalf.

"At around 1805 hrs, I was travelling towards Jung Tin Hall Road. Along one of the traffic junction beside Petrol Kiosk Shell, traffic light was 'RED', my vehicle was at a halt position. Upon traffic light turn 'GREEN', the traffic started moving and the car in front of me started moving. All of a sudden, the car in front of me stopped suddenly. I could not brake in time and resulted in the collision with the car in front of me. The driver and I came out to do a visual inspection of the situation. The driver was not hurt and asked to shift the vehicles away from the main road. He shifted the vehicle away from the main road and turned into Petrol Kiosk Shell to exchange particulars."
