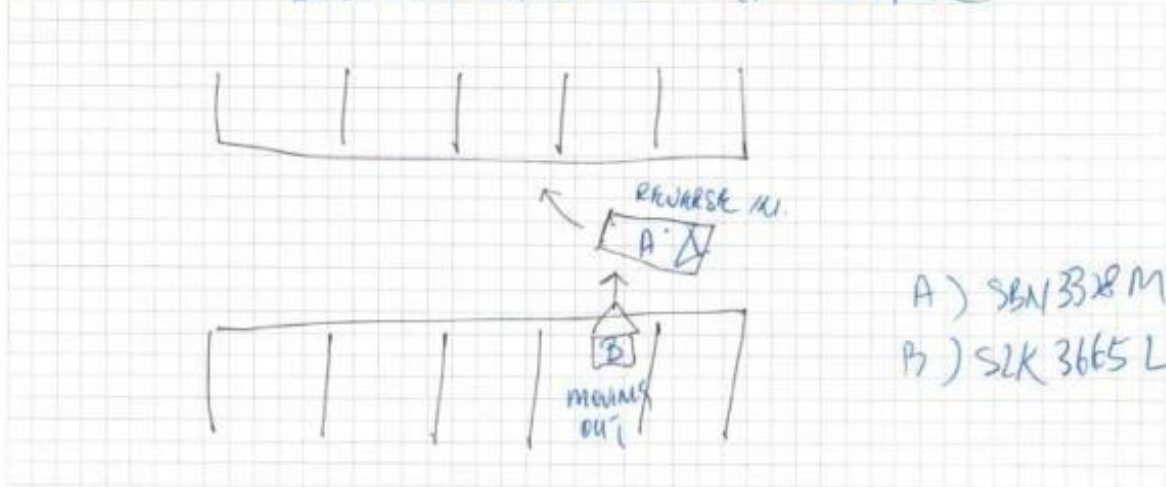

TRUCK PARKING CHANGING CPNAT CARPARK

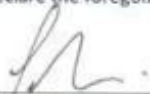


DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

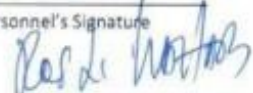

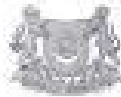

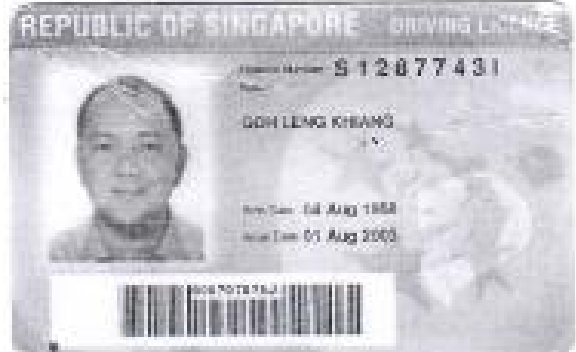
