We have received a claim from **K.KIM HIN AUTO PTE LTD** acting on behalf of the owner of SJZ 9074Y against your motor insurance policy.


Based on the accident report and accident scenario, liability is down against us. We will therefore proceed to negotiate for an amicable settlement with the Third Party.
