



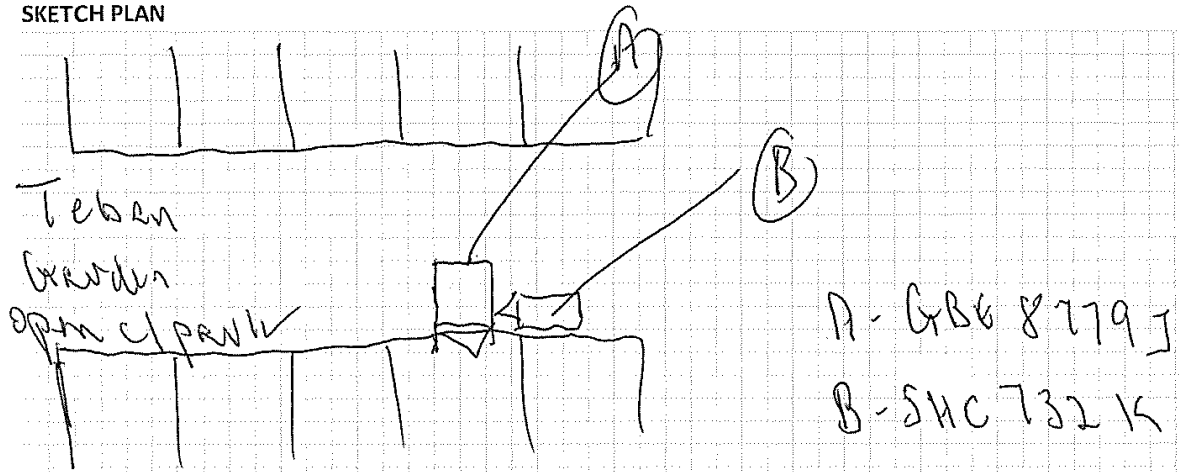

On 27/5/2019 at about 5.20pm, I was reversing my vehicle GBE 8779 J at the carpark of Teban Garden into a carpark lot.


Suddenly, a vehicle SHC 732 K collided onto my left hand side bumper.

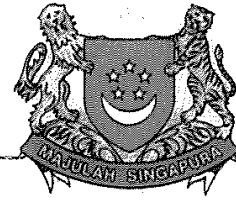

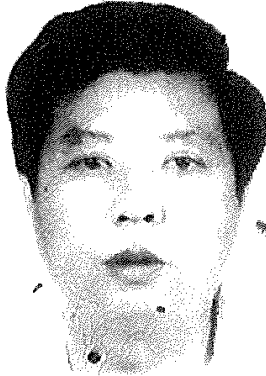

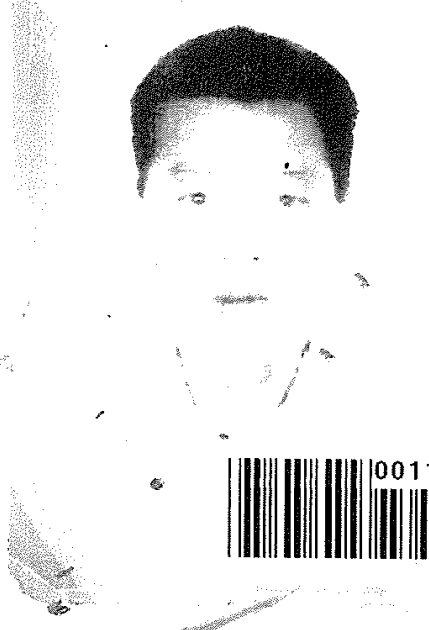
