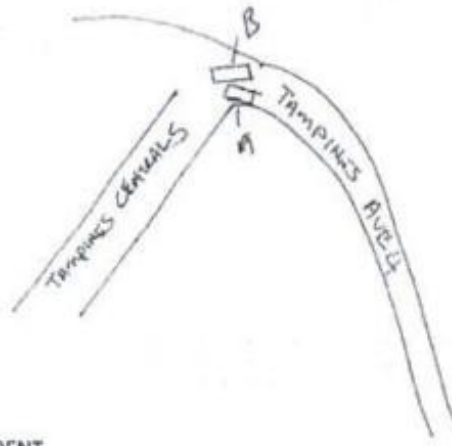




On 1/6/19 at about 1340 I was driving along Tampines Ave 4


