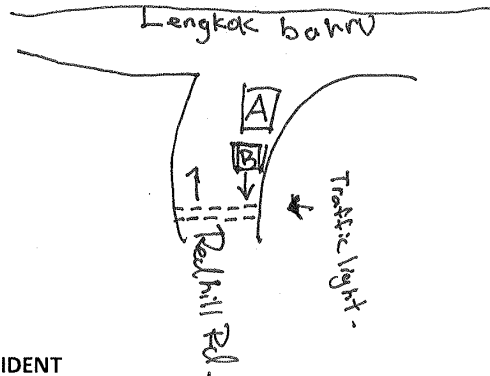

B = SKX 8356P

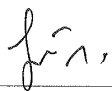


DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

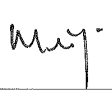
- 29/05/19 at 1316 at Redhill Road Traffic I was driving our customer vehicle to carry Roat test.
