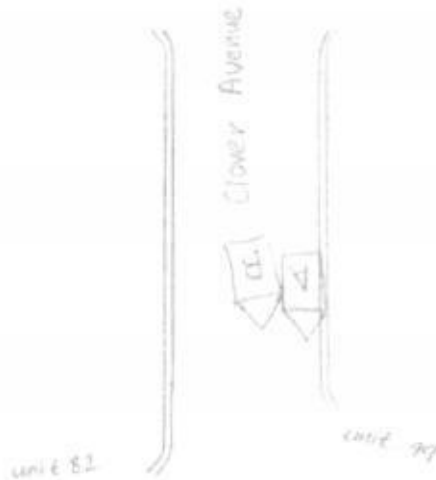

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 16 May 2019 at around 12.40 PM my vehicle was stationary
the driver curve slightly to the left
(SLP 5453 S)
at Clover Avenue near unit no. 99. Vehicle B was turning into unit no. 82, because of the
sharp turn into unit 82. As a result
