#### **Circumstances of Accident**

I WAS DRIVING ALONG BRADDELL ROAD TOWARDS UPPER SERANGOON ROAD AT BRADDELL UNDERPASS. THERE ARE 2 LANES ALONG BRADDELL UNDERPASS. I WAS DRIVING STRAIGHT WITHIN THE FIRST LANE AND WITHIN THE SPEED LIMITS AT AROUND 70KM/HOUR. THE ABOVE MENTIONED TAXI WAS DRIVING ON THE 2ND LANE. I WAS KEEPING IN MY LANE AND DRIVING NEXT TO THE TAXI WHICH IS ABOUT 1 METER BEHIND MY CAR, THE TAXI FILTERED INTO MY LANE AND HIT MY CAR AT THE FRONT LEFT SIDE OF THE PASSENGER DOOR WITH A LOUD BANG. THE TAXI DID NOT STOP AT THE SPOT OF THE ACCIDENT RIGHT AFTER THE ACCIDENT BUT CONTINUE TO DRIVE ON. I HAVE NO CHOICE BUT TO FOLLOW BEHIND HIM. I HONKED AND SIGNALLED HIM TO STOP. WE FINALLY CAME TO A STOP AT THE CHEVRON MARKING AT THE MERGER OF TOA PAYOH FLYOVER AND BRADDELL UNDERPASS. 
