



We refer to the below email.

Please be informed that we had spoken to the Insured Driver Mr Tan where he was informed about the TP video footage and scene photos showing contact between both vehicles. However, the Insured Driver Mr Tan now insisted that there was no damages to the TP vehicle. There were no scene photos provided by the Insured Driver to determine the damages of the TP vehicle taken at the time of the reported accident.

Meanwhile, we attached the coloured scene photos provided by the TP claimant for your reference. Based on the photos, there was likely a contact between both vehicles.

As Insured Driver would like to see the scene photos and damages to TP vehicle for his confirmation, we attached herewith some of the inspection photos with some comments from our Surveyor at the time of inspection.






The above photos show the general view of the Third Party vehicle.



The above photo shows the rear bumper under cover right portion of the Third party vehicle.





The above photos shows a closer view of the rear bumper under cover portion that sustained damages and the point of impact between both vehicles. The damages observed shows a vertical indentation which may likely correspond to the Insured's front number plate that is the most protruding portion of the vehicle that may have likely in contact with the rear bumper under cover of the taxi (please refer to the above scene photo).

Our surveyor is in the view that the damages observed to the Third Party vehicle is consistent to the nature of the accident and as per video footage provided.

Anyway, the adjusted proposed claim settlement amount to TP repairer is as below:


