Circumstances of Accident

I PARKED MY CAR IN THE CARPARK OF CENTRAL 8, AT TAMPINES CENTRAL 8 IN THE EVENING OF 21 MAY 2019 AT ABOUT 7PM. WHEN I WOKE UP THE NEXT MORNING I SAW SEVERAL MISSED CALLS AND MESSAGES FROM MY CAR WASHER INFORMING ME THAT MY CAR WAS INVOLVED IN AN ACCIDENT. I ARRIVED AT THE CARPARK AT ABOUT 7AM. I FOUND MY CAR TO HAVE SUFFERED MINOR DAMAGE TO THE FRONT LEFT FENDER AND BUMPER. THE CAR NEXT TO MINE, ON THE LEFT WAS BADLY DAMAGED. THERE WAS A NOTE FROM FROM ONE "BRYAN TAN" ON MY WINDSCREEN AS WELL AS A CONTACT CARD OF A TRAFFIC POLICE INVESTIGATING OFFICER. I CHECKED MY IN-CAR CAMERA FOOTAGE WHICH SHOWED THAT AT 11.53 PM ON 21 MAY 2019, A RED HONDA CAR LOST CONTROL WHILE COMING DOWN THE CARPARK RAMP. IT COLLIDED WITH THE SIDE WALL OF THE RAMP BEFORE TRAVELLING FORWARD AND COLLIDING WITH MY CAR AND THE CAR NEXT TO MINE. THE SAID "BRYAN TAN" IS UNCONTACTABLE. I HAVE BEEN INFORMED BY THE I.O THAT THIS IS A DRINK DRIVING CASE AND THE CAR PLATE NUMBER OF THE RED HONDA IS SJT6212S.

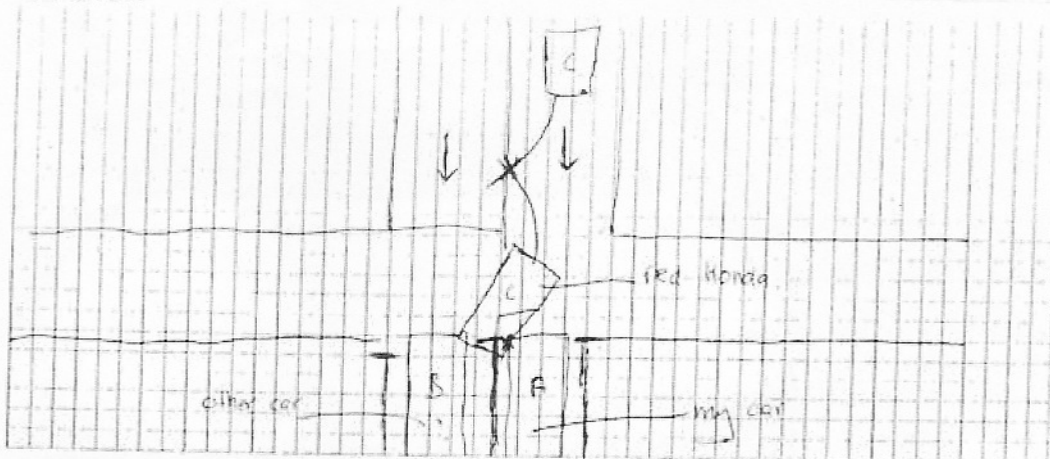

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I parked my car in the carpark of Centrepoint at Tampines Centrepoint, in the evening of 21 May 2019 at about 7pm. When I woke up the next morning I saw several missed calls and messages from my car insurer informing me that my car was involved in an accident. I arrived at the carpark at about 7am I found my car to have suffered minor damage to the front left fender and a bumper. The car next to mine was on the left, was badly damaged. There was a note from one "Bryan Tan" on my windscreen as well as a contact card of a traffic police investigating officer. I checked my in-car camera footage which showed that at 11:53pm on 21 May 2019, a red Honda car lost control while coming down the carpark ramp. It collided with the side wall of the ramp before travelling forward and colliding with my car and the car next to mine. The said "Bryan Tan" is uncontactable. I have been informed by the IC that this is a drink driving case and the car plate number of the red Honda is 3J762128.
