

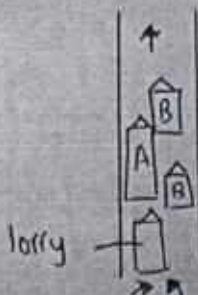


On 10/06/2019 @ 19:30hrs, I was driving my bus PC69564 along Jln

road @ the accident site.



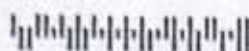
