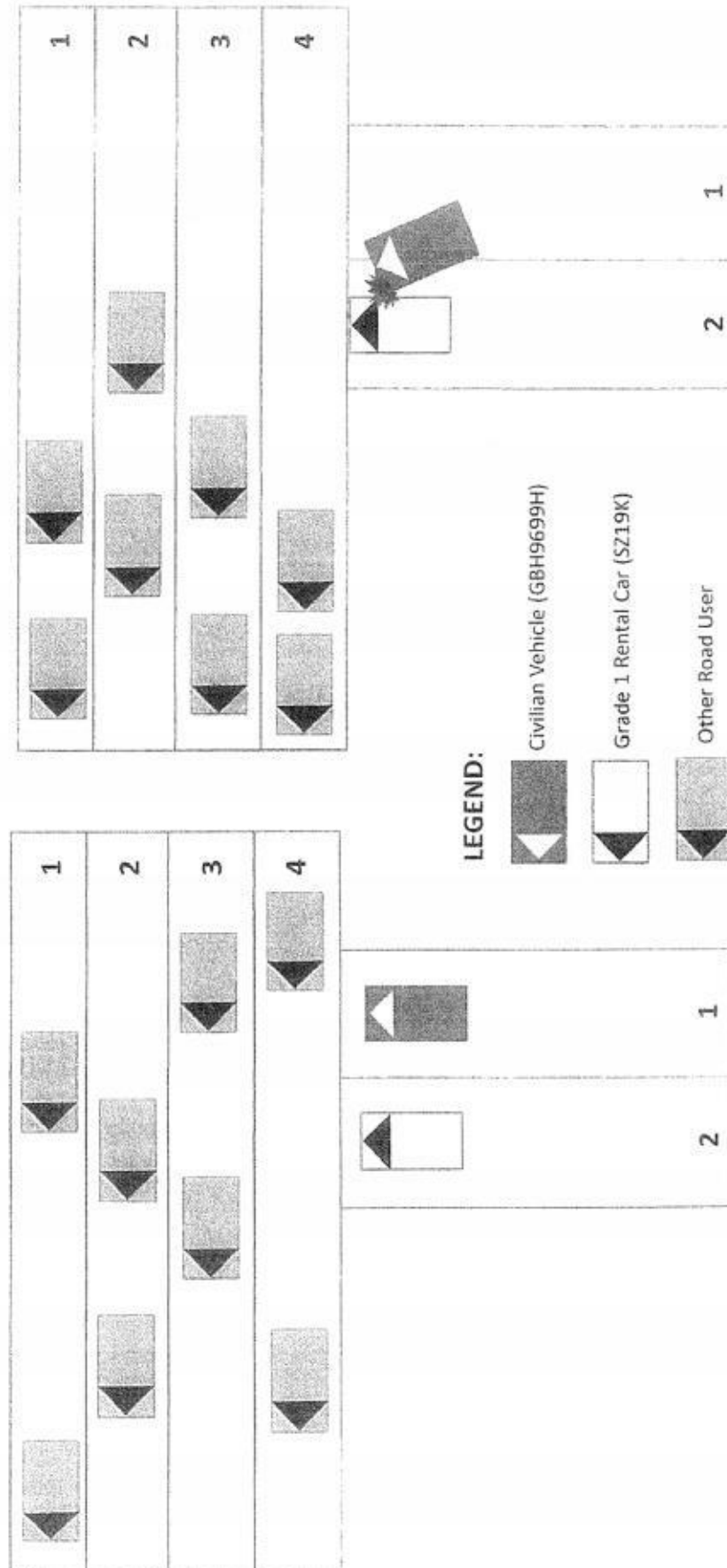

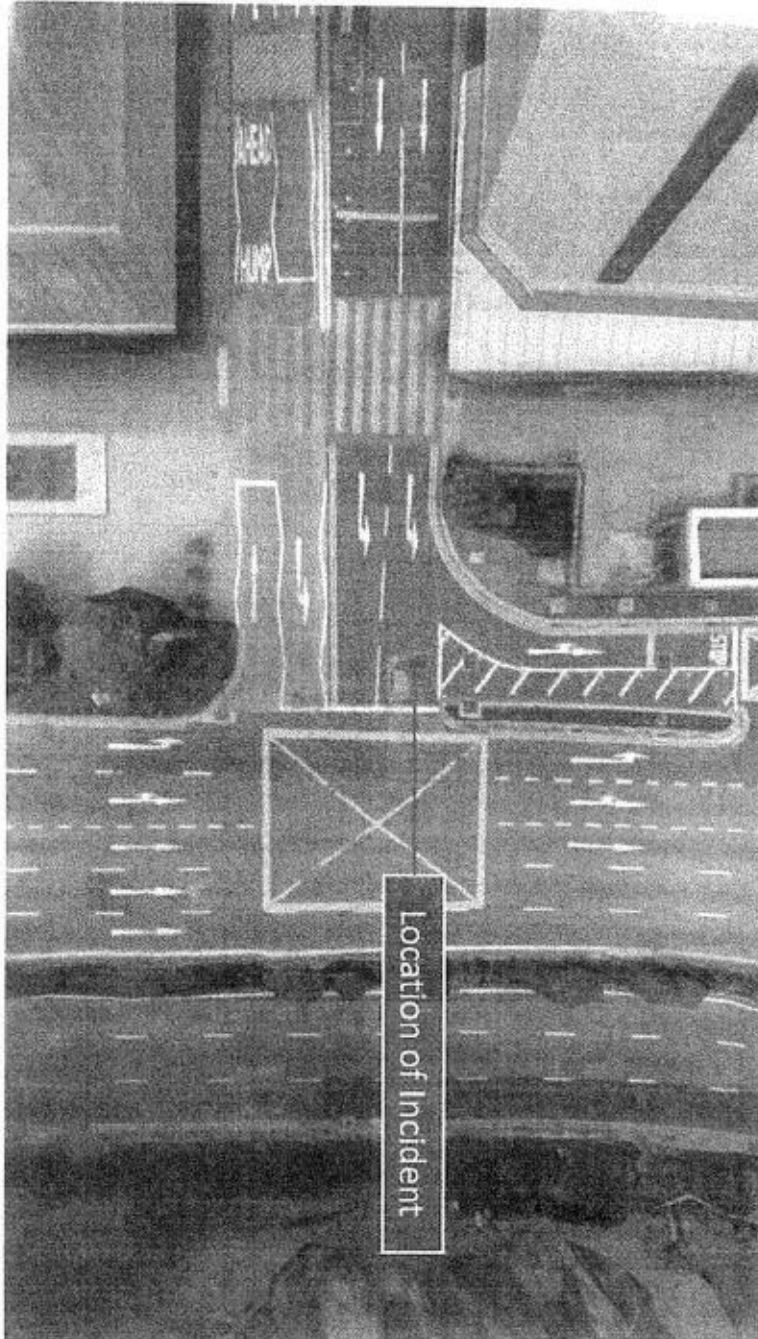

# Schematic Diagram of Incident



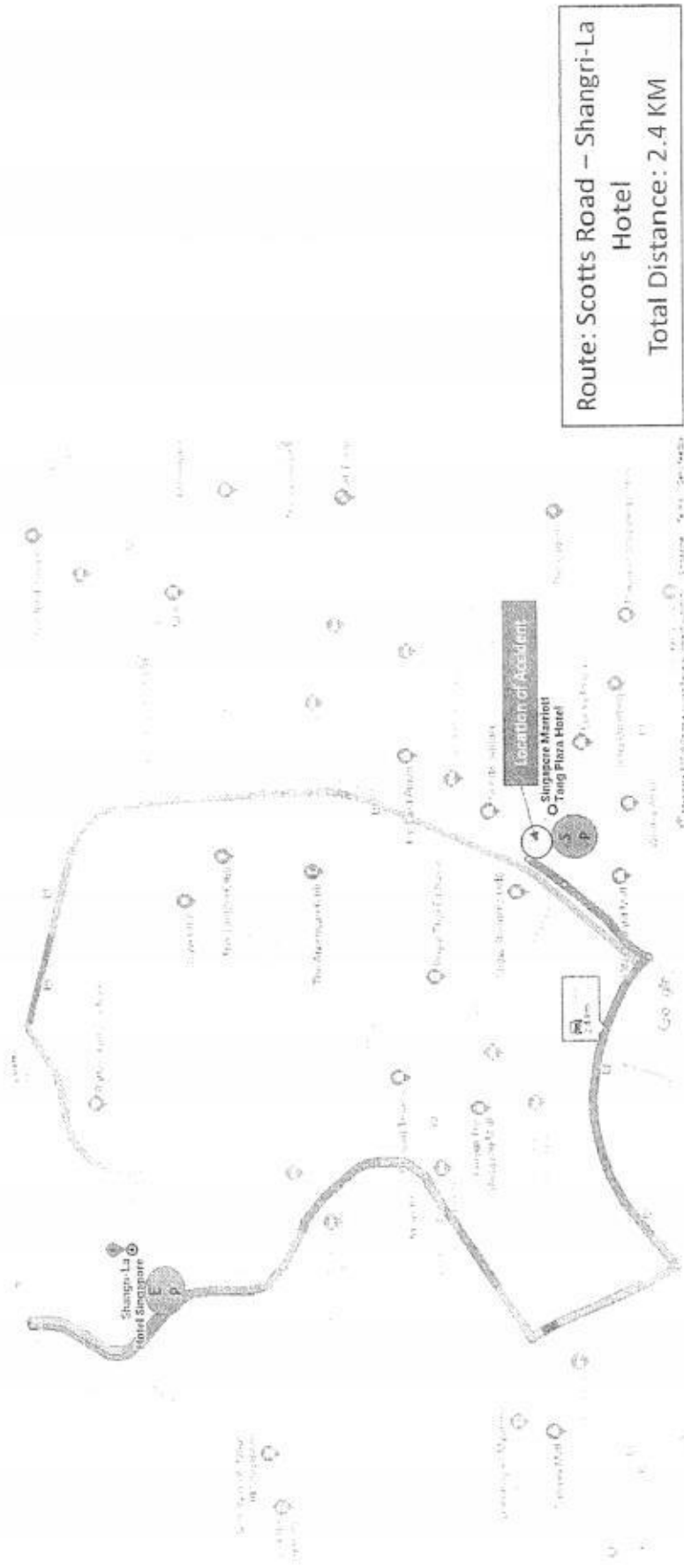
## Close-up View of Incident Location



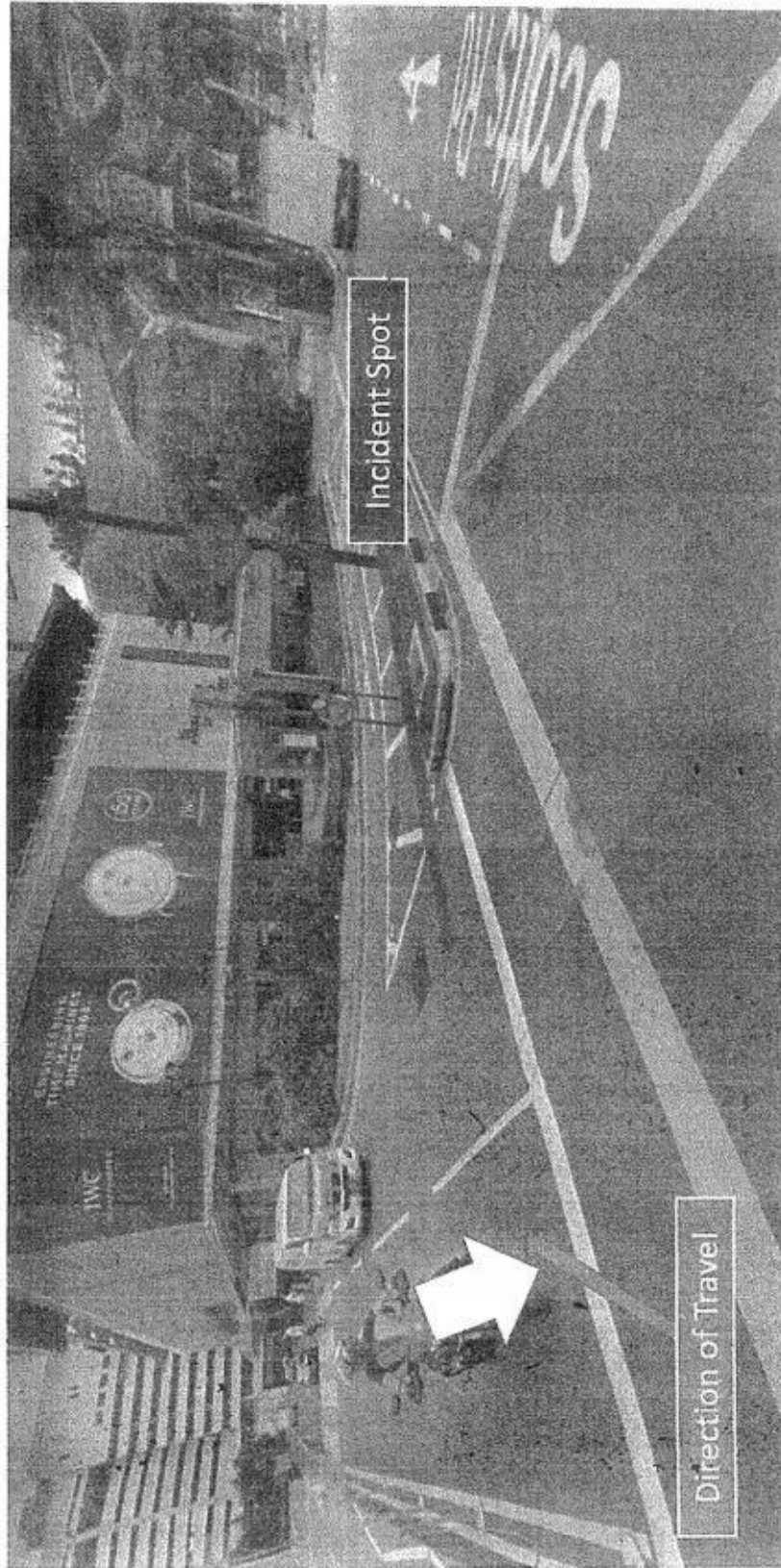
Distance Travelled from SP: 0.1 KM

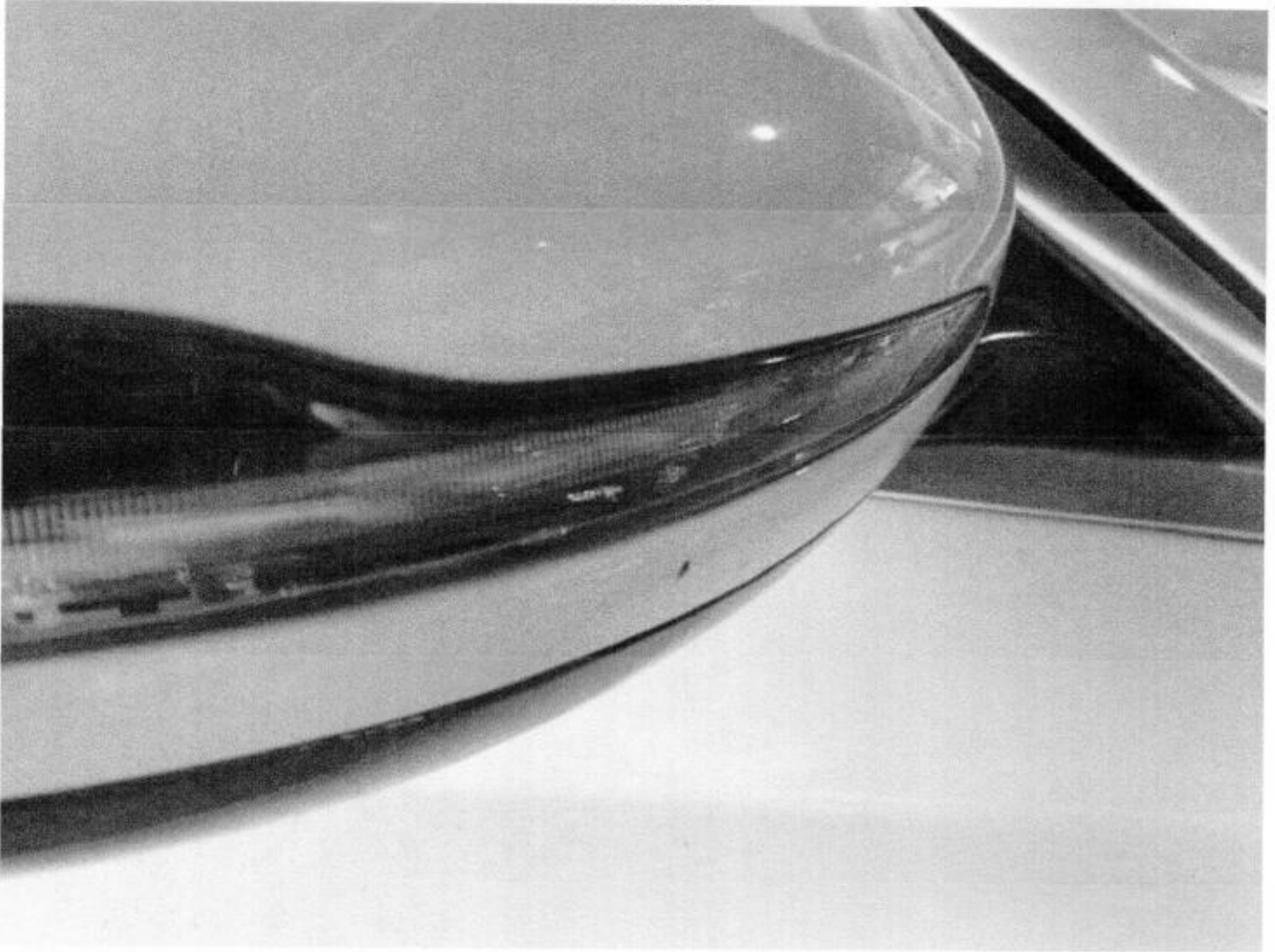
