**SKETCH PLAN**



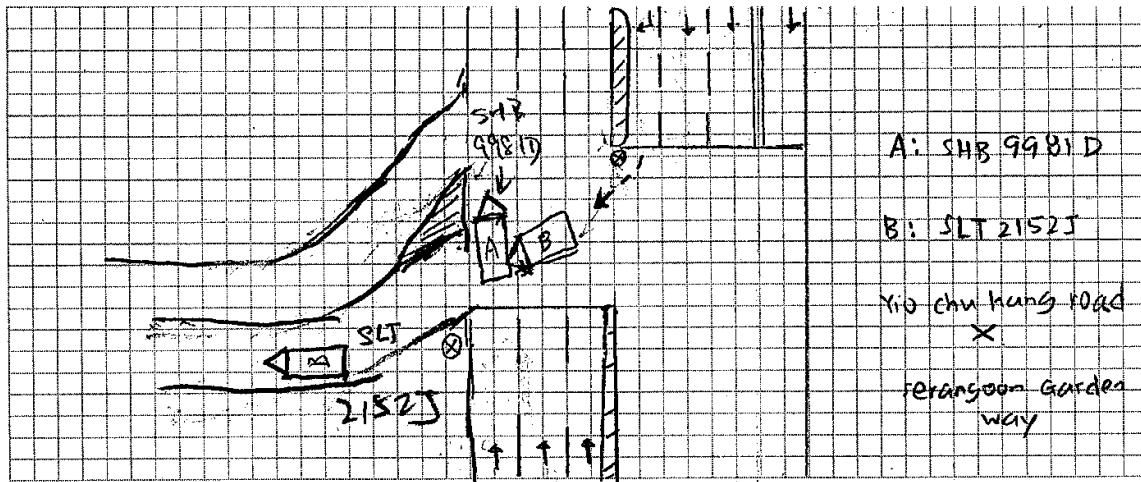
