ACCIDENT INVOLVING SHD 5627T & SJS 4036C ON 28/02/2014

We refer to the above matter.

TP reported that while he was driving along Sims Ave, 2nd lane from the right before turning into Geylang Lorong 23. His vehicle had stopped due to the traffic light in front was red and collided by OI vehicle from behind.

OI reported that he was driving along Sims Ave near Geylang Lorong 23, TP vehicle was abruptly cutting into his lane from the left without signalling and collided with OI vehicle.

We have reviewed both reports. Basing on the damaged profiles on both vehicles, TP's vehicle sustained the damages on the rear right side of vehicle instead of rear portion and it appears to have damages by changing lane. As such, TP version is not credible in view of damaged profile.

As above mentioned, we intend to reject the claim. Kindly let us have your approval / comment (if any).
