CONTINUATION OF REPORT

Brief Details.

I am commonly known as Mr Quek. I am working as a taxi driver. I am currently residing in Blk 709 Woodlands Dr 70 #10-05.

On 08/06/2019 at about 2040 hrs, I was travelling along BKE towards SLE after Mandai exit. There was a multiple-chained collision involving 5 vehicles. The first vehicle which was a car with vehicle plate number SLE8610T collided with another car with vehicle plate number SKV197U from the front to the rear. This resulted in the second car front to collide with the third vehicle which was my vehicle with car plate number SHD5838B on my rear. My car as a result then collided a lorry in front of me with plate number GBE1694R. The lorry's front as a result collided with the vehicle in front of him which was a foreign vehicle with car plate number QT5828.

The front and rear of my vehicle were seriously scratched and dented inwards. I had no passengers in my vehicle. I am unsure of the exact details of the damage assessment of other vehicles clearly.

I was prescribed with 5 days of MC via Intermedical 24 Hr Clinic due to pain on the rear of my neck, my back area and left side of the leg as a result of the collision. Police and ambulance had attended to the scene however no one was conveyed. There is CCTV installed in my taxi front which recorded the incident.
