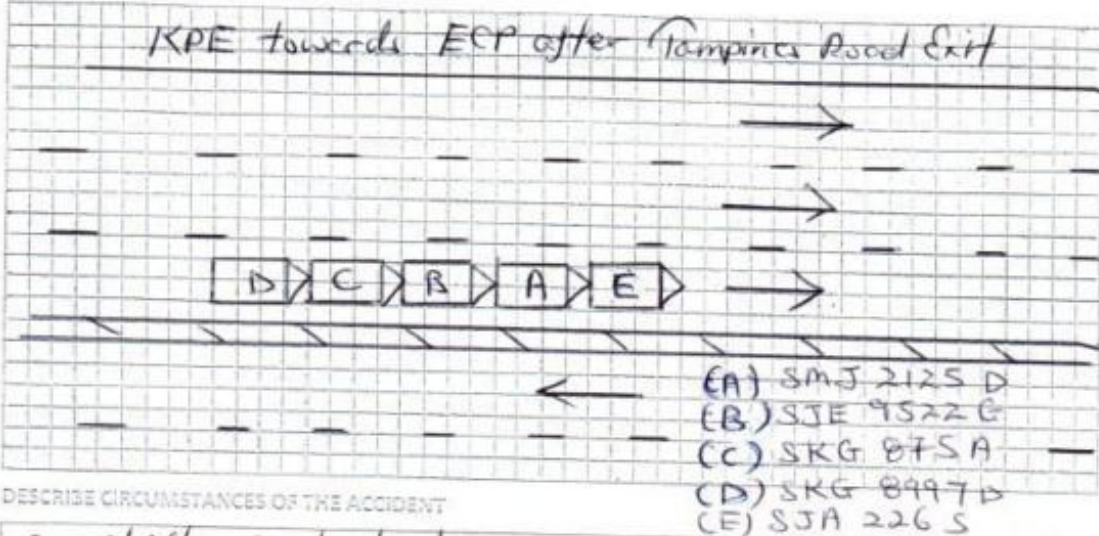

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 12/06/2019 at about 1010 hrs at along KPE towards ECP after Tampines Road Exit. When I alighted, I realised that it was Vehicle (B) who hit onto my Rear Portion of my vehicle (A) causing damages to my vehicle. It was a chain collision of total 5 vehicles involved. 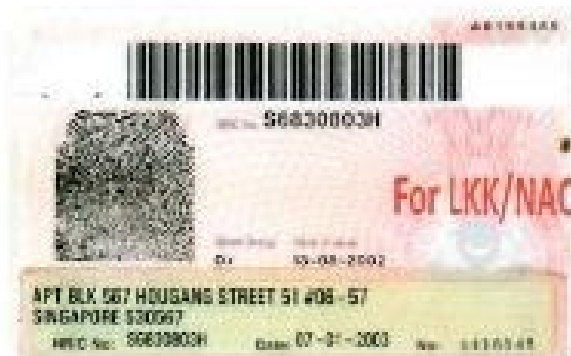

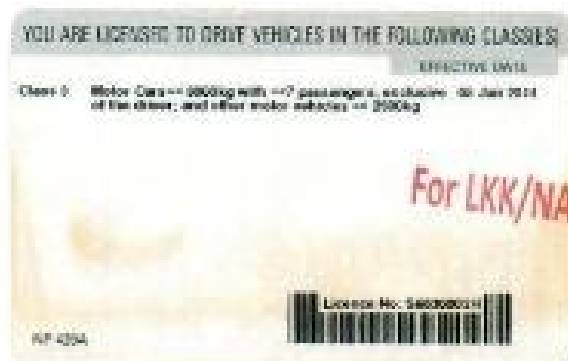

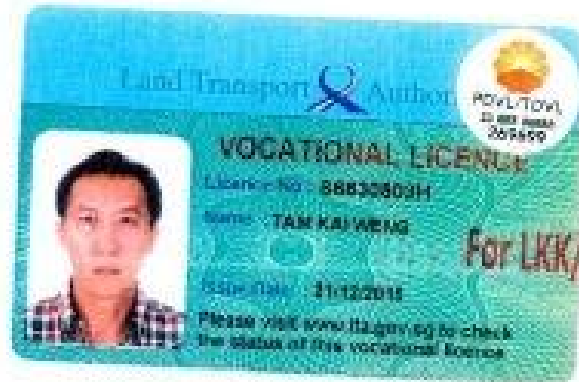
