**Brief Details.**

On the 12/06/2019 at about 1250hrs, I parked my vehicle - One White BMW 216D (Registration Plate Number: SLM5890D) at the Open Carpark of Blk 210 Marsiling Crescent (unknown lot number). I secured my vehicle and left. Everything was normal.

On the same day at about 1320hrs, I came back to retrieve my vehicle and discovered that there was a paint chip and marks on the front right region of my vehicle. No note was left behind.

I made a check on my in-vehicle CCTV and discovered that on the same day at about 1306hrs, One White Nissan (Registration Plate Number: SBH1010Z) had grazed against the front right region of my vehicle when picking up a passenger. I strongly believe that the incident was what caused the damage.

I wish to state that I am not aware if there is any CCTV at the incident location which secures where my vehicle was parked and whether or not it recorded the whole incident.
