### Brief Details.

On 10/06/2019 at about 10.00 p.m., I was driving the SMRT Bus Service No. 858, SG1030U, along Yishun Avenue 5 at the junction of Yishun Street 11.

While driving straight, I saw from the opposite side of the road, there was a white Kia, SJL2666J. Since it was still green light, I had continued driving straight. Out of a sudden, the white car had made a u-turn, while I was still driving inside the junction. Due to that, I was not able to avoid the collision and had hit onto the car's left rear.

Because of the collision, 2 of my passengers suffered injuries (one had a fall and the other knocked onto the railing) and were conveyed to Khoo Teck Puat Hospital.

The damages to the bus are: cracked windscreen, fallen front bumper, some dents and scratches on the front side of the bus.
